

**COASTAL ZONE MANAGEMENT & RESTORATION
ADVISORY COMMITTEE MINUTES
OF
January 9, 2024**

1. Chairman Mickey Thomas called the regular meeting of the Coastal Zone Management & Restoration Advisory Committee to order at 5:00p.m. Tuesday, January 9, 2024, in the Council Meeting Room, 2nd Floor, Government Tower. Mr. Thomas led the Invocation and the Pledge of Allegiance.
