#### **IN SPECIAL SESSION**

## **JANUARY 4, 2024**

The Inaugural Ceremony for the 2024-2028 Terrebonne Parish Council and Parish President commenced at 6:00 p.m. at the Barry P. Bonvillain Civic Center with an Invocation offered by Rev. James Morrison, St. Matthew's Episcopal Church.

The Presentation of Colors was presented by the Terrebonne Parish Color Guard. Assistant Council Clerk Keith Hampton led the Pledge of Allegiance, followed by the St. Matthew's Episcopal School Choristers who sang the National Anthem.

The Chairwoman, Ms. J. Domangue, called the meeting to order at 6:15 p.m. at the Barry P. Bonvillain Civic Center.
