ORDINANCE NO. 9548

AN ORDINANCE AUTHORIZING THE PARISH PRESIDENT (OR HIS DESIGNEE) TO EXECUTE A COOPERATIVE ENDEAVOR AGREEMENT FOR RIGHT OF USE AGREEMENT BETWEEN THE TERREBONNE PARISH CONSOLIDATED GOVERNMENT AND FLETCHER TECHNICAL COMMUITY COLLEGE FOR ACCESS TO DRAINAGE DITCH.

WHEREAS, Section 2-11 of the Terrebonne Parish Home Rule Charter requires an ordinance to convey or lease or authorize the conveyance or lease of any lands or property of the parish government.; and

WHEREAS, the Terrebonne Parish Consolidated Government (TPCG) and Fletcher Technical Community College (Fletcher), desire to enter into a Cooperative Endeavor Agreement for Fletcher's access and use of TPCG's property for the period set forth in the agreement (agreement attached herein); and

SECTION I

NOW, THEREFORE BE IT ORDAINED by the Terrebonne Parish Council on behalf of the Terrebonne Parish Consolidated Government, that the Parish President, Jason Bergeron, is hereby authorized to sign and to execute all documents necessary to execute a Cooperative Endeavor Agreement for Fletcher a non-exclusive right of use for access to TPCG's property for the period set forth in the agreement and approved by the legal department.

ORDINANCE NO. 9549

AN ORDINANCE TO AMEND CERTAIN SECTIONS OF CHAPTER 2, ADMINISTRATION, ARTICLE IV, ADMINISRATIVE ORGANIZATIONAL STRUCTURE OF THE TERREBONNE PARISH CODE OF ORDINANCES PURSUANT TO THE AUTHORITY OF SECTION 4-13 OF THE HOME RULE CHARTER TO CHANGE AND REALLOCATE THE FUNCTIONS, POWERS, DUTIES AND RESPONSIBILITIES OF CERTAIN DEPARTMENTS, TO AMEND THE ADMINISTRATIVE ORGANIZATIONAL CHART ACCORDINGLY; AND TO FURTHER AMEND PORTIONS OF THE CODE TO AVOID CONFLITS WITH THE REORGANIZATION OF THE PARISH DEPARTMENTS.

WHEREAS, Section 4-13 of the Home Rule Charter of the Parish of Terrebonne authorizes the Parish President to propose administrative reorganization by the creation, change, alteration, consolidation or abolition of parish departments and the reallocations of the functions, powers, duties and responsibilities of such departments, "including those provided for in [the] charter"; and

WHEREAS, in accordance with Charter Section 4-13, the presiding officer of the Terrebonne Parish Council introduces this ordinance for the implementation of the Parish President's proposed plan, detailed more fully in Sections I and II herein below; and

WHEREAS, the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, finds that the Parish President's proposed administrative reorganization and amended Parish Organizational Chart, annexed to and incorporated in this Ordinance, are satisfactory; and

WHEREAS, for purposes of complimenting the reorganization of the parish departments, and to remove any conflicts in the Code of Ordinances, the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, finds it necessary to make amendments to the Code outlined in Sections III and IV of this Ordinance herein below; and

NOW THEREFORE BE IT ORDAINED by the Terrebonne Parish Council on behalf of the Terrebonne Parish Consolidated Government that:

SECTION I

- **A.** The civic center department shall be and is hereby abolished. The existing Section 2-85. "Civic center department" shall be and is hereby repealed in its entirety. Administration, operational management, and event planning of and for the Barry P. Bonvillain Civic Center, its facilities, and equipment, shall be organized under the Venues and Destinations Division under the Quality of Life Department.
- **B.** The communications department shall be and is hereby created, and a new Section 2-85. "Communications department" shall be and is hereby enacted as follows:

Sec. 2-85. Communications Department.

- (a) The head of the communications department shall be the Chief Communications Officer.
- (b) The Chief Communications Officer shall be and is hereby designated the custodian of public records for the Terrebonne Parish Consolidated Government.

- (c) The Chief Communications Officer shall also direct and be responsible for the following:
 - (1) Community relations;
 - (2) Administration and operational management of the Parish website;
 - (3) Administration and operational management of the Parish social media accounts;
 - (4) Provide information technology administration.
 - (5) Other such responsibilities as may be directed by the president.
- (d) The communications department shall consist of the following subordinate divisions:
 - (1) Public relations division;
 - (2) Information technology division.

SECTION II

The following sections of Chapter 2, Article IV of the Terrebonne Parish Code of Ordinances shall be and are hereby amended as follows (using strikeout formatting to indicate deleted language and underlining to indicate additions):

Sec. 2-72. Parish manager-Chief administrative officer.

- (a) The parish manager chief administrative officer ("CAO") shall be appointed by the president, subject to approval by the council, and shall serve at the pleasure of the president.
- (b) Subject to the direction of the president, the parish manager <u>CAO</u> shall supervise all departments, offices and agencies of the parish government, and perform such other functions as may be directed by the president.

* * *

Sec. 2-74. Finance department.

- (a) The head of the finance department shall be the chief financial officer.
- (b) The chief financial officer shall direct and be responsible for the following:
 - (1) Collection (except where specifically otherwise provided for by law) and custody of all monies of the parish government from whatever source.
 - (2) Assistance to the president in the preparation of the annual operating budget and capital improvement budget.
 - (3) Maintenance of a record of indebtedness and the payment of the principal and interest on such indebtedness.
 - (4) Ascertaining that funds are available for payment of all contracts, purchase orders and any other documents which incur financial obligation for the parish government, and that such documents are in accordance with established procedures.
 - (5) Disbursement of all funds from the parish treasury.
 - (6) Administration of a uniform central accounting system for all parish departments, offices and agencies, using nationally accepted standards where applicable.
 - (7) Preparation of a monthly statement of revenues and expenditures, which shall be completed and made available for public inspection not later than twenty (20) days after the end of each month.
 - (8) Procurement of all personal property, materials, supplies and services required by the parish government under a central purchasing system for all departments, offices and agencies in accordance with applicable state law, council policy and administrative requirements.

- (9) Preparation of all intergovernmental grant applications on behalf of the parish government and informing departments, offices and agencies of all relevant local, state and federal programs.
- (10) Maintenance of an inventory of all property, real and personal.
- (11) Investment of idle funds, as permitted by law, so as to receive the maximum rate of return.
- (12) Provide information technology administration.
- (13)(12) Perform utility billing and collection.
- (14)(13) Provide general administrative services.
- (15)(14) Other responsibilities as may be directed by the president.
- (c) The finance department shall consist of the following subordinate divisions:
 - (1) Accounting division;
 - (2) Information technology division;
 - (3) Customer service division; and
 - (4)(3) Purchasing division.

Each division shall have a division head who shall be under the supervision of the chief financial officer.

* * *

Sec. 2-78. Parks and recreation department Quality of Life Department.

- (a) The parks and recreation quality of life department shall be headed by the director of the parks and recreation quality of life department.
- (b) The director of the parks and recreation quality of life department shall direct and be responsible for the following:
 - (1) <u>Administration and operational management of p</u>Parks, recreational facilities, and playgrounds.
 - (2) <u>Administration and operational management of Recreation athletics</u> activities <u>and</u> programs.
 - (3) Other leisure time activities.
 - (4) Administration and operational management of cultural facilities and events.
 - (5) Other such responsibilities as may be directed by the president.
- (c) The parks and recreation quality of life department shall consist of the following divisions:
 - (1) Youth recreation services division;
 - (2) Adult recreation services division;
 - (3) Special recreation services division; and
 - (4) Recreation facilities maintenance division.
 - (1) Athletics and leisure division;
 - (2) Cultural enrichment division; and
 - (3) Venues and destinations division.

Each division shall have a division head who shall be under the supervision of the director of the parks and recreation quality of life department.

(Author's note and Cross Reference: Section 4-08 of the Charter creates and describes the Parks and Recreation Department. Section 4-13 of the Charter authorizes the reorganization

of parish departments, including those established in the Charter. This ordinance reorganizes and renames the Parks and Recreation Department to be the Quality of Life Department.)

Sec. 2-80. Risk management and human resources department.

- (a) The risk management and human resources department shall be headed by the director of the risk management and human resources department.
- (b) The director of the risk management and human resources department shall direct and be responsible for the following:
 - (1) Administration of all personnel matters, other than immediate supervision of personnel as otherwise provided in this article;
 - (2) Administration of all insurance procurement and management matters;
 - (3) Administration of all claims;
 - (4) Administration of safety and health programs;
 - (5) Administration of a position classification plan that shall provide for the classification of all positions on the basis of the duties and responsibilities of each position;
 - (6) Administration of a compensation/salary plan for all positions in the parish service;
 - (7) Maintain and administer a personnel policy manual to carry out the provisions of this section;
 - (8) Other such responsibilities as may be described by the president.
- (c) The risk management and human resources department shall be responsible for the management of the following areas of responsibility:
 - (49) Employee services.
 - (210) Recruitment, training and development.
 - (311) Insurance and claims management.
 - (4) (12) Safety and health.
- (d) The risk management and human resources department shall consist of the following subordinate divisions: (1) Risk management division;
 - (2) Human resources division.

* * *

Sec. 2-87. Organizational chart.

The organizational chart, as attached to Ordinance No. 9206 ____[insert this ordinance number], is hereby adopted as the official organizational chart of the Terrebonne Parish Consolidated Government and shall be maintained on file by the Terrebonne Parish Council Clerk.

SECTION III

To compliment the amendment to Section 2-72 of the Terrebonne Parish Code of Ordinances as amended in Section II of this ordinance hereinabove, the following Sections of the Terrebonne Parish Code of Ordinances shall be and are hereby amended by replacing the phrase "parish manager" or the phrase "Parish Manager" with the phrase "chief administrative officer":

- Section 9-37. Appeals against denial of variance by the reviewing authority. *in the first paragraph*.
- Section 24-3. General policy. at subsection (c).

SECTION IV

To compliment the changes to Section 2-85 of the Terrebonne Parish Code of Ordinances as amended in Section I of this ordinance hereinabove, Section 2-402, "Supervision of facilities" and Section 2-406, "Barry P. Bonvillain Civic Center, rental rates and user fees, regulations" shall be and are hereby amended as follows (using strikeout formatting to indicate deleted language and underlining to indicate additions):

Sec. 2-402. - Supervision of facilities.

The cultural facilities of the Terrebonne Parish Consolidated Government as specified in section 2-401 shall be supervised by the director of the quality of life department and managed as follows:

- (1) Barry P. Bonvillain Civic Center shall be its own department as previously provided by Ordinance No. 6304 and codified at section 2-406 of this article.
- (2) The remaining cultural facilities shall be within a division or divisions of the quality of life a department designated by the parish president.

Sec. 2-406. - Barry P. Bonvillian Civic Center, rental rates and user fees, regulations.

- (a) The Barry P. Bonvillain Civic Center shall be under the supervision of the Civic Center department director.
- (b) All applications for rental or use of the Barry P. Bonvillain Civic Center shall be administered by <u>civic center management under</u> the <u>office of the director of the civic center supervision of the quality of life</u> department, and such rental or use shall be consistent with those rental rates or user fees and requirements as established by Ordinance Nos. 5747 and 5818 of the Parish Council. The application and request forms, rental rates, and user fees and regulations attached as an exhibit to Ordinance No. 5747 is made part hereof and are hereby adopted by the Parish Council.
 - (1) Arena Configuration:

* * *

(8) Move in, move out, rehearsals: One-half (½) of the established base rental rate if on day other than performance or use day. Activities on move in/out days, other than the day of the performance, shall take place only during normal business hours. Move in/out activities outside of normal business hours shall take place only at the discretion and in accordance with the requirements of the director of the civic center management.

SECTION V

If any word, clause, phrase, section or other portion of this ordinance shall be declared null, void, invalid, illegal, or unconstitutional, the remaining words, clauses, phrases, sections and other portions of this ordinance shall remain in full force and effect, the provisions of this ordinance hereby being declared to be servable.

SECTION VI

This ordinance shall become effective upon approval by the Parish President or as otherwise provided in Section 2-13(b) of the Home Rule Charter for a Consolidated Government for Terrebonne Parish, whichever occurs sooner.
