AN ORDINANCE DEDICATING AND ACCEPTING THE MAINTENANCE/OPERATION OF THE STREET(S), DRAINAGE SERVITUDES, SEWER, AND RIGHTS-OF-WAY FOR **ENERGIZE** "EVANGELINE OAKS SUBDIVISION;" AND ACCEPT STREETLIGHTS; AND TO INCORPORATE "RUE EVANGELINE," "RUE JEAN LUC," RUE JEANETTE," "RUE ELOI," AND THE EXTENSION OF "RUE DES AFFAIRES" INTO THE ENHANCED 911 EMERGENCY RESPONSE SYSTEM FOR THE PURPOSE OF PROVIDING A BETTER MEANS OF LOCATING ADDRESSES; AND TO SET FORTH AN EFFECTIVE DATE FOR THE INCORPORATION OF STREET NAME(S), TO INFORM THE PROPER AGENCIES OF THE STREET NAME(S), AND TO AUTHORIZE THE INSTALLATION OF THE APPROPRIATE STREET SIGN(S), AND TO ADDRESS OTHER MATTERS RELATIVE THERETO.

SECTION I

BE IT ORDAINED that the Terrebonne Parish Council, on behalf of Terrebonne Parish Consolidated Government, dedicates and accepts the maintenance/operation of the street(s), drainage servitudes, sewer, and rights-of-way; and energize and accept the streetlights as depicted on a plat, prepared on April 3, 2024, by David A. Waitz Engineering & Surveying, Inc. titled "Evangeline Oaks Subdivision," a copy of which is attached hereto and made a part hereof;

BE IT FURTHER ORDAINED effective on the <u>15th</u> day of <u>MAY</u>, <u>2024</u>, that "Rue Evangeline," "Rue Jean Luc," "Rue Jeanette," "Rue Eloi," and the extension of "Rue Des Affaires" be incorporated into the Enhanced 911 Emergency Response System;

ORDINANCE NO. 9570

AN ORDINANCE TO RESCIND ORDINANCE NO. 9563 FOR ERROR THEREIN, AND TO ENACT A NEW ORDINANCE AUTHORIZING THE RELOCATION OF A TERREBONNE PARISH PRECINCT POLLING LOCATION FOR THE ELECTION OF NOVEMBER 5, 2024, AND ALL SUBSEQUENT ELECTIONS

SECTION I

WHEREAS, The Terrebonne Parish Council passed Ordinance No. 9563 on March 27, 2024, relocating Precinct 029 from Honduras Elementary School to the East Houma Recreation Center; and

WHEREAS, Ordinance No. 9563 contained an error in that it stated the first election at the new location was scheduled for July 17-19, 2024; and

WHEREAS, the first election date is actually November 5, 2024, not July 17 - 19, 2024; and

WHEREAS, TPCG finds it necessary to rescind Ordinance 9563 and adopt a new, corrected ordinance to remedy the error; and

WHEREAS, notice of the relocation of these polling places shall be published in Terrebonne Parish's Official Journal by the governing authority and the Parish Board of Election Supervisors in accordance with La. R.S. 18:535; and

WHEREAS, proper notice of the relocation of the polling places shall be given, as

applicable, in accordance with La. R.S. 18:536; and

WHEREAS, nothing herein shall change the Geographical boundaries of the precinct.

SECTION II

NOW THEREFORE BE IT ORDAINED that beginning on the November 5, 2024, election, and continuing every election thereafter, the following polling location shall be relocated as follows:

1) Pct. 029- Honduras Elementary School located at 530 Grand Caillou Road, Houma, LA 70363 **is moved to** East Houma Recreation Center located at 126 Boundary Road, Houma, LA 70363.

BE IT FURTHER ORDAINED that as required by law, the appropriate persons give notice pursuant to La. R.S. 18:535 and La. R.S. 18:536; and

SECTION III

NOW, THEREFORE BE IT ORDAINED by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, that, in due, regular and legal sessions convened, this ordinance is enacted.

SECTION IV

NOW, LET IT FURTHER BE ORDAINED by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, that Ordinance No. 9563 is hereby rescinded.

AN ORDINANCE TO AMEND THE 2024 ADOPTED OPERATING BUDGET OF THE TERREBONNE PARISH CONSOLIDATED GOVERNMENT FOR THE FOLLOWING ITEMS AND TO PROVIDE FOR RELATED MATTERS.

- I. UTILITIES-ELECTRIC DISTRIBUTION, \$350,000
- II. DEDICATED EMERGENCY FUND, \$2,648,949
- III. DEDICATED EMERGENCY FUND, \$6,525,690
- **IV.** DEDICATED EMERGENCY FUND, \$757,000
- **V.** DRAINAGE, \$2,000

SECTION I

WHEREAS, Administration is requesting funding for various street light repairs in the amount of \$350,000, and

WHEREAS, the funding source is from the Utilities Department fund balance.

NOW, THEREFORE BE IT ORDAINED, by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, that the 2024 Adopted Operating Budget be amended for the Utilities Department. (**Attachment A**)

SECTION II

WHEREAS, Terrebonne Parish Consolidated Government received an additional

\$2,648,949 in 2024 from FEMA for Hurricane Ida expenses, and

WHEREAS, these funds will be placed into the Dedicated Emergency Fund to reimburse the Parish for hurricane expenses.

NOW, THEREFORE BE IT FURTHER ORDAINED, by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, that the 2024 Adopted Operating Budget be amended for the Dedicated Emergency Fund. (**Attachment B**)

SECTION III

WHEREAS, Administration is requesting funding of \$6,525,690 for the Dedicated Emergency Fund expenses from Hurricane Ida, and

WHEREAS, the funding is from the Dedicated Emergency Fund, fund balance.

NOW, THEREFORE BE IT ORDAINED, by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, that the 2024 Adopted Operating Budget be amended for the Emergency Fund expenses. (**Attachment C**)

SECTION IV

WHEREAS, Administration is requesting funding of \$757,000 for the interest payment and agent fees of the Hurricane Recovery Revenue bonds, and

WHEREAS, the funding is from the Dedicated Emergency Fund, fund balance.

NOW, THEREFORE BE IT FURTHER ORDAINED, by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, that the 2024 Adopted Operating Budget be amended for the interest payment for the Hurricane Recovery Revenue bonds. (**Attachment D**)

WHEREAS, the Drainage Department received \$2,000 reimbursement for damages that occurred to a grate-screw gate, and

WHEREAS, this reimbursement needs to be reflected in the Contractor's Repairs account.
