The Chairwoman, Ms. J. Domangue, called the meeting to order at 6:00 p.m. in the Terrebonne Parish Council Meeting Room. The Invocation and the Pledge of Allegiance were led by Council Member J. The following resolution was offered by MR. J. AMEDÈE and seconded by MR. C. HARDING:

RESOLUTION NO. 23-465

A resolution approving the holding of an election in the Village East Fire Protection District of the Parish of Terrebonne, State of Louisiana, on Saturday, April 27, 2024, to authorize the renewal of a special tax therein.

WHEREAS, the Board of Commissioners of the Village East Fire Protection District of the Parish of Terrebonne, State of Louisiana (the "Governing Authority"), acting as the

governing authority of the Village East Fire Protection District of the Parish of Terrebonne, State of Louisiana (the "District"), adopted a resolution on December 11, 2023, calling a special election in the District on Saturday, April 27, 2024, to authorize the renewal of a special tax therein; and

WHEREAS, the Governing Authority of the District has requested that this Parish Council, acting as the governing authority of the Parish of Terrebonne, State of Louisiana, give its consent and authority for the District to hold the aforesaid election, and in the event that the election carries to continue to levy and collect the special tax provided for therein; and

WHEREAS, as required by Article VI, Section 15 of the Constitution of the State of Louisiana of 1974, it is now the desire of this Parish Council to approve the holding of said election and in the event that the election carries, to continue to levy and collect the special tax provided for therein;

NOW, THEREFORE, BE IT RESOLVED by the Parish Council of the Parish of Terrebonne, State of Louisiana, acting as the governing authority of said Parish, that:

SECTION 1. In compliance with the provisions of Article VI, Section 15 of the Constitution of the State of Louisiana of 1974, and in accordance with the request of the Board of Commissioners of the Village East Fire Protection District of the Parish of Terrebonne, State of Louisiana, this Parish Council hereby approves the holding of an election in the District, on Saturday, April 27, 2024, at which election there will be submitted the following proposition, to-wit:

MILLAGE RENEWAL PROPOSITION

Shall the Village East Fire Protection District of the Parish of Terrebonne, State of Louisiana (the "District"), continue to levy and collect a special tax of 15 mills on all property subject to taxation in the District (an estimated \$517,467 reasonably expected at this time to be collected from the levy of the tax for an entire year), for a period of 10 years, beginning with the year 2027 and ending with the year 2036, for the purpose of acquiring, constructing, maintaining and operating the District's fire protection facilities and paying the cost of obtaining water for fire protection purposes, including fire hydrants rentals and service?

SECTION 2. In the event the election carries, this Parish Council does hereby further consent to and authorize the District to continue to levy and collect the special tax provided for therein.

The Chairwoman recognized Mr. Craig Stewart, Attorney at Law representing Mr. Rainey, who spoke of Mr. Rainey's passion and motivation for the well-being of the children and elders in his district.

Mr. G. Michel moved, seconded by Mr. D. Babin, "THAT the Council vote either to provide Mr. Rainey an option to complete a rehabilitation procedure based on Council designated items or that Mr. Rainey be removed immediately from the Recreation District No. 1 Board and that a voice vote be taken to determine which of the two actions will be taken."

He then shared that they are waiting for funding to start the process of building the park.

At the request of Mr. D. Babin, the Chairwoman recognized Ms. Tammy Knight, Dularge resident, who addressed the concerns regarding the hiring of applicants.

The Chairwoman recognized Mr. Brent Rodrigue, Dularge resident, who also shared background on Recreation District No. 10's Board options and challenges faced concerning their park.

Discussion ensued relative to Recreation District No. 10 and the holding of a meeting with all concerned parties to have an open dialogue and address some of the issues on both sides.

Mr. J. Amedée moved, seconded by Mr. C. Harding, "THAT, the time now being 6:38 p.m., the Council enter public hearings."

SECTION I

WHEREAS, the Animal Shelter received donations of \$8,607, and

WHEREAS, the donations will be put into the Medical & Drugs account.

NOW, THEREFORE BE IT ORDAINED, by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, that the 2023 Adopted Operating Budget be amended for the Animal Shelter. (**Attachment A**)

SECTION II

WHEREAS, the Parish has been awarded \$5,885 for the Emergency Management Performance Grant Program - 2022 from the State of Louisiana, Governor's Office of Homeland Security and Emergency Preparedness, and

WHEREAS, the dollars will be reimbursement for the operations associated with the Office of Emergency Preparedness including daily duties conducted by the office staff.

NOW, THEREFORE BE IT FURTHER ORDAINED, by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, that the 2023 Adopted Operating Budget of the Terrebonne Parish Consolidated Government be amended for the Emergency Preparedness Department. (**Attachment B**)

SECTION III

WHEREAS, Terrebonne Parish Consolidated Government has received an \$8,000 grant from Keep Louisiana Beautiful, Inc., and

WHEREAS, the funds will be used during the Christmas parade festival to promote recycling and discourage littering, and equipment will be purchased to assist with trash collection.

NOW, THEREFORE BE IT FURTHER ORDAINED, by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, that the 2023 Adopted Operating Budget be amended for Keep Louisiana Beautiful grant. (**Attachment C**)

SECTION IV

WHEREAS, Administration is requesting funding for the Tennis Court lights in the amount of \$3,900, and

WHEREAS, the funding source is from the Parishwide Recreation fund balance.

NOW, THEREFORE BE IT FURTHER ORDAINED, by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, that the 2023 Adopted Operating Budget be amended for the Tennis Court Lights. (**Attachment D**)

SECTION V

WHEREAS, the Parish is required to recognize projected revenues which has an unfavorable variance of 5% or more over the current budget, and

WHEREAS, the Sales Tax Revenue Account requires a decrease for the following funds:

- GENERAL FUND, (\$805,583)
- PUBLIC SAFETY FUND, (804,583)
- ROAD & BRIDGE FUND, (\$604,119)
- DRAINAGE TAX FUND, (\$604,119)
- SALES TAX FUND, (\$604,119)
- TERREBONNE PARISH LEVEE & CONSERVATION DISTRICT, (\$604,121)

NOW, THEREFORE BE IT FURTHER ORDAINED, by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, that the 2023 Adopted Operating Budget be amended to recognize the necessary adjustment for the Sales Tax Revenue Accounts listed above. (**Attachment E**)

SECTION VI

WHEREAS, the Parish is required to recognize projected revenues and expenditures which have an unfavorable variance of 5% or more over the current budget, and

WHEREAS, the Criminal Court Fund expenditures from various accounts require a \$181,278 decrease, and

WHEREAS, the Criminal Court Fund revenues from Court Fines require a \$83,751 decrease, and

WHEREAS, the net effect to fund balance is an increase of \$97,527.

NOW, THEREFORE BE IT FURTHER ORDAINED, by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, that the 2023 Adopted Operating Budget be amended to recognize the necessary adjustment for the Criminal Court Fund. (**Attachment F**)

SECTION VII

WHEREAS, the Parish is required to recognize projected revenues and expenditures which have an unfavorable variance of 5% or more over the current budget, and

WHEREAS, various accounts for the Parish Prisoners Fund expenditures and revenues need to be amended for the remainder of the year, and

WHEREAS, an additional transfer of \$200,000 is required, and

WHEREAS, the transfer is from the General Fund, fund balance.

NOW, THEREFORE BE IT FURTHER ORDAINED, by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, that the 2023 Adopted Operating Budget be amended to recognize the necessary adjustment for the Parish Prisoners Fund. (**Attachment G**)

SECTION VIII

WHEREAS, Administration is requesting funding of \$32,000 for the Non-District Recreation Fund, and

WHEREAS, the funding source will be from the Parishwide Recreation Fund, fund balance.

NOW, THEREFORE BE IT FURTHER ORDAINED, by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, that the 2023 Adopted Operating Budget be amended for the Non-District Recreation Fund. (**Attachment H**)

SECTION IX

WHEREAS, Terrebonne Parish Consolidated Government received an additional \$5,821,076 in 2023 for Hurricane Ida insurance claims, and

WHEREAS, these funds will be placed into the Dedicated Emergency Fund to reimburse the Parish for hurricane expenses.

NOW, THEREFORE BE IT FURTHER ORDAINED, by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, that the 2023 Adopted Operating Budget be amended for the Dedicated Emergency Fund. (**Attachment I**)

SECTION X

WHEREAS, Administration is requesting funding of \$8,507,263 for the Dedicated Emergency Fund expenses from Hurricane Ida, and

WHEREAS, the funding is from the Dedicated Emergency Fund, fund balance.

NOW, THEREFORE BE IT FURTHER ORDAINED, by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, that the 2023 Adopted Operating Budget be amended for the Emergency Fund expenses. (**Attachment J**)

SECTION XI

NOW, THEREFORE BE IT FURTHER ORDAINED, by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, hereby authorizes Gordon Dove, Parish President, to execute any and all documents for these amendments as approved by the legal department.

SECTION XII

If any work, clause, phrase, section, or other portion of this ordinance shall be declared null, void, invalid, illegal, or unconstitutional, the remaining words, clauses, phrases, sections, and other portions of this ordinance shall remain in full force and effect, the provisions of this ordinance hereby being declared to be severable.

SECTION XIII

This Ordinance shall become effective upon approval by the Parish President or as otherwise provided in Section 2-13(b) of the Home Rule Charter for a Consolidated Government for Terrebonne Parish, whichever occurs sooner.

WHEREAS, The Terrebonne Parish Council has the authority to enact ordinances, approve or deny the filing of any lawsuits, the pursuit of any claims, the authorization of settlements and/or dismissals of lawsuits whether by the Parish President directly or indirectly through attorneys, experts, consultants, or otherwise; and

WHEREAS, it is the intent of this amendment to grant the council with the authority to approve or deny the pursuit of any claims, filing of any lawsuits, and pursuit of any settlements under the State and Local Coastal Resources Management Act, La. R.S. 49:214.21; and

WHEREAS, Section 2-11 of the Terrebonne Parish Home Rule Charter requires an ordinance to adopt or amend an administrative code; and

WHEREAS, TPCG is in need of amending ordinance 6273 as codified in Chapter 28, Article XI, Section 28-271 concerning the State and Local Coastal Resources Management Act, La. R.S. 49:214.21 et. seq.

NOW, THEREFORE, BE IT ORDAINDED by the Terrebonne Parish Council on behalf of TPCG that:

SECTION I

The Terrebonne Parish Code is hereby amended by adding sections, to be designated (d) and (e) of Terrebonne Parish at Article XI, Chapter 28, Section 28-271, with underline to show additions: **Sec. 28-271** – **General**

- (d) Notwithstanding anything to the contrary in the Parish Code, the Parish President shall not dismiss and/or settle the current lawsuits referenced herein, TPCG vs. Louisiana Department of Natural Resources, et al, Docket No. 185576(E) and Terrebonne Parish Consolidated Government vs. Duval, Funderburk, Sunbery, Richard, & Watkins, APLC, et al, Docket No. 188363(E), without first receiving approval from a two thirds majority of the parish councils voting membership, whether present or not present at a Parish Council meeting.

R.S. 49:214.21 et seq. against any person(s) whether natural or juridical, neither directly nor indirectly, whether through attorneys, experts, consultants, or otherwise.

AN ORDINANCE TO CERTIFY AND APPROVE AN AD VALOREM TAX EXEMPTION IN ACCORDANCE WITH LA. CONST. ART. VII, SEC. 21(F) FOR MACHINERY, EQUIPMENT, AND OTHER CAPITAL IMPROVEMENTS TO BE ASSESSED AT 301 BAYOU DULARGE ROAD, HOUMA LA, 70363, OWNED BY BOLLINGER HOUMA SHIPYARDS, LLC IN REGARDS ITS INDUSTRIAL AD VALOREM TAX EXEMPTION APPLICATION (NO. 20210609-ITE).

WHEREAS, the Industrial Ad Valorem Tax Exemption Program is regulated under the Louisiana Administrative Code Title 13, Part I, Chapter 5, promulgated in accordance with Article VII, Part 2, Section 21(F) of the Louisiana Constitution of 1974, with the intent to incentivize job creation and job retention by offering manufacturers ad valorem tax exemptions under application to the Louisiana Department of Economic Development for up to two terms of five years each; and

WHEREAS, Bollinger Shipyards Houma, LLC submitted its initial application for the Program through the Louisiana Department of Economic Development on equipment and other capital improvements it owns and will be assessed for ad valorem taxes at 301 Bayou Dularge Road, Houma LA 70363, and

WHEREAS, Bollinger's application #20210609 was approved by the Louisiana Department of Economic Development and they entered into that certain Contract for Exemption of Ad Valorem Taxes, a copy of which is attached hereto and made a part of this Ordinance; and

WHEREAS, in accordance with LAC 13:I. 503(H), the Louisiana Department of Economic Development notified the TPCG, through the Terrebonne Economic Development Authority, of the approved application, and the Terrebonne Parish Council is now afforded an opportunity to identify the application on the agenda of its public meeting notice and to conduct a public meeting for the purposes of approving or rejecting the application;

WHEREAS, should the Terrebonne Parish Council fail to take timely action, then the application will be deemed approved by this governing body in accordance with LAC 13:I. 503(H)(1); and

WHEREAS, the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government finds that support of these types of exemptions play a vital role in incentivizing the creation and retention of jobs in Terrebonne Parish; and

BUDGET & FINANCE COMMITTEE

DECEMBER 11, 2023

The Chairman, Mr. Dirk J. Guidry, called the Budget & Finance Committee meeting to order at 5:30 p.m. in the Terrebonne Parish Council Meeting Room. The Invocation was offered, and the Pledge of Allegiance was led by Mr. B. Pledger. Upon roll call, the Committee Members recorded as present were: D. W. Guidry, Sr., D. J. Guidry, S. Trosclair, B. Pledger, C. Harding, G. Michel and J. Amedée. Ms. J. Domangue and Mr. D. Babin were recorded as absent. A quorum was declared present.

Chief Financial Officer Kandace Mauldin gave a PowerPoint presentation and handouts overviewing the CDBG Disaster Recovery, Hometown Revitalization Program and the Resilient Communities Infrastructure Program. Ms. Mauldin shared the current and pending allocations the Parish will receive, highlighting that the program requirements are that funds must be related to storm events, the projects must be within Terrebonne Parish, and the Parish must meet the objective to benefit low to moderate income families.

The Chairman reported that Ms. J. Domangue and Mr. D. Babin would not be in attendance to the meeting due to personal matters then recognized Parish President-Elect Jason Bergeron who was in the audience for the proceedings.

Planning and Zoning Director Christopher reported that a series of public input meetings were held as part of the program requirements and shared his intention to hold another meeting before the application is submitted in February 2024.

At Mr. C. Harding's request, Ms. Mauldin clarified that new federal guidelines were being followed regarding communities qualifying as disadvantaged and would provide greater detail on definitions at a later date.

Mr. Pulaski outlined a list of projects for the 1st FEMA allocation of funds in the amount of 41.4 million dollars as follows: Geraldine Pump Station, Finding Our Roots Museum, Downtown Amphitheater/Museum, Support to the Seafood industry, Bayou Terrebonne Pump Station, Bayou Burn Project, Old Shell Property, Aviation and Avionic Program at Fletcher, Small Business Program Incubator, and Activating the Bayous. He then mentioned alternate projects, including jail relocation, local cost shares, completing streets, improvements for the downtown area, and small business grants.

At the request of Mr. G. Michel, Mr. Pulaski stated that he needed a resolution from the Council confirming its support of the projects to accompany the application by January 8, 2024 for FEMA's approval of the projects.

- Mr. G. Michel shared his opinions regarding the purchase and repurposing of the old post office building in downtown Houma as part of the proposed projects.
- Mr. B. Pledger noted his concerns regarding the location of many of the proposed projects and options for improvements in other areas.
- At Mr. J. Amedée's request, Mr. Pulaski noted that the list of projects could be revised with the approval of FEMA after it has been received by FEMA.

Discussion ensued relative to possible changes after the application is submitted and definitions pertaining to these grants.

Mr. Pulaski gave an overview of the projects for the 2nd FEMA allocation and the proposed timelines for submitting proposals to FEMA for approval.

PUBLIC SERVICES COMMITTEE

DECEMBER 11, 2023

The Chairman, Mr. Carl Harding, called the Public Services Committee meeting to order at 6:20 p.m. in the Terrebonne Parish Council Meeting Room. The Invocation was offered, and the Pledge of Allegiance was led by Mr. C. Harding. Upon roll call, Committee Members recorded as present were: D. W. Guidry, Sr., D. J. Guidry, S. Trosclair. B. Pledger C. Harding, G. Michel, and J. Amedée. Committee Members J. Domangue and D. Babin were recorded as absent. A quorum was declared present.

At this time, the Chairman ceded the Chair to the Vice-Chairman.

The Vice-Chairman called for discussion regarding Agenda Item No. 1 – Discussion with possible action regarding the causes and effects of improving quality of life through sewerage and drainage.

Mr. C. Harding shared his concerns regarding sewerage costs and the lack of services in some areas of the parish.

Parish Manager Mike Toups stated that he was not aware of anyone paying for sewage services and not receiving them. He then shared that anyone having an issue with their sewer service should contact the Waterworks office for assistance.

Several Committee Members shared that there are residents across the parish that are not part of the Parish's sewerage system with separate water treatment facilities and that federal grants are available to assist low-income areas in providing new facilities.

At the request of Mr. J. Amedée, Planning and Zoning Director Christopher Pulaski clarified that new subdivision owners and contractors assume responsibility for the types of system they utilize, and that the Parish is only responsible for the drainage infrastructure.

At Mr. B. Pledger's request, Mr. Pulaski noted that the sewerage infrastructure is regulated by the Louisiana Department of Health and that more research would need to be done before a decision could be made if the Parish was interested in maintaining sewerage systems. He then shared that he would like to discuss ideas regarding the wastewater master plan and prioritize areas of need.

Parish Attorney Julius Hebert stated that an ordinance could be done to assume responsibility for and maintain the Parish's sewerage system and that the standards can be regulated through the ordinance.

- Mr. J. Amedée clarified that the Louisiana Department of Health regulates discharge and that the Public Services Commission regulates the sewerage rates which can be adjusted periodically. He then noted that there could be costs associated with taking over these plants.
- Mr. B. Pledger recommended that discussions be scheduled with Magnolia Water to inform them about the issues Terrebonne Parish residents are having with their sewerage systems.

The Vice-Chairman recognized Mr. Wilfred Joseph, an Octavia Street resident, who addressed the Council to ask for assistance with drainage issues. He shared his concerns about the safety of the children that walk to school then requested materials and funding to help the children of the Levytown community.
