AN ORDINANCE AMENDING THE PARISH CODE OF TERREBONNE PARISH, CHAPTER 18, ARTICLE V (STOPPING, STANDING & PARKING), DIVISION 2 (PARISH), SECTION 18-223 (NO PARKING ZONES): TO AUTHORIZE THE DESIGNATION OF A "NO PARKING ZONE" ON THE EVEN NUMBERED SIDE OF MAGNOLIA COURTYARD; TO AUTHORIZE THE INSTALLATION OF APPROPRIATE SIGNS; AND TO ADDRESS OTHER MATTERS RELATIVE THERETO.

SECTION I

BE IT ORDAINED, by the Terrebonne Parish Council, in regular session convened, acting pursuant to the authority invested in it by the Constitution and laws of the State of Louisiana, the Home Rule Charter for a Consolidated Government for Terrebonne Parish, and including, but not limited to, LSA R.S. 33:1368 and other statutes of the State of Louisiana, and to amend the Codes of Terrebonne Parish, Chapter 18, Article V, Division 2, Parish Section 18-223 to authorize the designation of a "No Parking Zone on the even numbered side of Magnolia

Courtyard to authorize the installation of the appropriate signs as required in the Manual on Uniform Traffic Control Devices.

SECTION II

If any word, clause, phrase, section or other portion of this ordinance shall be declared null, void, invalid, illegal, or unconstitutional, the remaining words, clauses, phrases, sections and other portions of this ordinance shall remain in full force and effect, the provisions of this ordinance hereby being declared to be severable.

SECTION III

Any ordinance or part thereof in conflict herewith is hereby repealed.

SECTION IV

This ordinance shall become effective upon approval by the Parish President or as otherwise provided in Section 2-13(b) of the Home Rule Charter for a Consolidated Government for Terrebonne Parish, whichever occurs sooner.

B. A proposed ordinance to clarify the parameters of the "No Parking" zone on the left side of Boundary Road

The Chairman recognized Mr. C. J. Stoufflet, Jean Ellen Ave., who explained that in 2001, a "No Parking" zone was approved on the northwest side of Boundary Road, but has not been enforced because it is unclear of the Parish's authority over the property. He stated that the proposed ordinance will clear the uncertainties up by establishing "No Parking" on the northwest side of Boundary Road from the edge of the blacktop to the property line of the residents who live on Jean Ellen Ave. He requested support of the proposed ordinance.

Chairman P. Rhodes relinquished the Chair to Vice-Chairman A. Tillman.

Councilman P. Rhodes displayed pictures of the area on Boundary Road where parking is a problem.

The Vice-Chairman recognized City of Houma Police Chief P. Boudreaux, who explained that the "No Parking" zone that is currently established was a result of a Neighborhood Watch Meeting where safety of the children was a concern.

Councilman C. Voisin expressed his concerns relative to not allowing motorists to park across from the recreational facility on Boundary Road causing them to have to park as far as across from Grand Caillou Road, of which they have to cross on foot, which is very dangerous.

Upon questioning by Councilman P. Rhodes, Parish Attorney C. Alcock stated that including further clarification of the area into the ordinance would not be considered a substantial change.

A discussion ensued relative to the parking situation on Boundary Road across from the recreational area.

Upon questioning, Planning & Zoning Director P. Gordon stated that even though it has been a few years ago, he recalls it was his recommendation at that time to establish a "No Parking" zone on Boundary Road due to safety issues.

A further discussion ensued to the parking situation on Boundary Road across from the recreational area.

ORDINANCE NO. 7197

AN ORDINANCE AMENDING CHAPTER 18, ARTICLE V, DIVISION II, SEC. 18-223 OF THE TERREBONNE PARISH CODE TO CLARIFY THE PARAMETERS OF THE NO-PARKING ZONE ON THE LEFT (NW) SIDE OF BOUNDARY ROAD; AND TO PROVIDE FOR RELATED MATTERS.

WHEREAS, Sec. 1-06 of the Home Rule Charter for the Parish of Terrebonne provides that parish government shall have the right, power and authority to pass all ordinances requisite or necessary to promote, protect and preserve the general welfare, safety, health, peace and good order of the parish, including, but not by way of limitation, the right, power and authority to pass ordinances on all subject matters necessary, requisite or proper for the management of parish affairs, and all other subject matter without exception, subject only to the limitation that the same shall not be inconsistent with the constitution or expressly denied by general law applicable to the parish; and

WHEREAS, it has come to the attention of the Parish Council that the current provision for a no-parking zone on the left (northwest) side of Boundary Road needs clarification; and

NOW, THEREFORE BE IT ORDAINED by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, that:

SECTION I

Section 18-223 of the Terrebonne Parish Code shall be amended to delete the following:

* * * * * * * *

The entire left (northwest) side (side nearest the residences). Any vehicle traveling on Boundary Road shall respect the signs erected and maintained under the provisions of this section. (Ord. No. 6486)

And to amend Section 18-223 of the Terrebonne Parish Code to replace the deleted language with the following:

* * * * * * * *

Boundary Road, the entire left (northwest) side from the roadway to the private property line of the residences- which area encompasses the entire public right of way.

SECTION II

If any word, clause, phrase, section or other portion of this ordinance shall be declared null, void, invalid, illegal or unconstitutional, the remaining words, clauses, phrases, sections and other portions of this ordinance shall remain in full force and effect, the provisions of this ordinance hereby being declared to be severable.

SECTION I

AN ORDINANCE TO AMEND CHAPTER 2, ARTICLE XIII, SECTION 2-406 REGARDING RENTAL RATES FOR THE HOUMATERREBONNE CIVIC CENTER.

WHEREAS, the Parish Council, upon the recommendation of the parish administration desires to clarify the special non-profit rates and create certain parameters for move-in, move-out code provisions; and

NOW THEREFORE, BE IT RESOLVED, by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, that

SECTION I

Section 2-406 shall be amended to read as follows:

Sec. 2-406. Houma-Terrebonne Civic Center, rental rates and user fees, regulations.

- (a) The Houma-Terrebonne Civic Center shall be under the supervision of the civic center department director.
- (b) All applications for rental or use of the Houma-Terrebonne Civic Center shall be administered by the office of the director of the civic center department, and such rental or use shall be consistent with those rental rates or user fees and requirements as established by Ordinances 5747 and 5818 of the parish council. The application and request forms, rental rates and user fees and regulations attached as an exhibit to Ordinance 5747 is made a part hereof and are hereby adopted by the parish council.

Rental rate terms and conditions (Exhibit A):

(1) Arena configuration:

- a. Public ticketed entertainment attractions, concerts, stage productions, athletic events, mardi gras activities--two thousand five hundred dollars (\$2,500.00) base rental fee against ten (10) percent of gross proceeds after taxes, whichever figure is greater, computed per performance, plus a five hundred dollars (\$500.00) set up fee.
- b. General meetings, conferences, graduations, assemblies, banquets, meal functions, dances: two thousand five hundred dollars (\$2,500.00) base rental fee per day where no admission is charged plus a five hundred dollars (\$500.00) set up fee.

(2) Theatre configuration:

- a. Hall A or B: Public ticketed entertainment attractions, concerts, stage productions, athletic events, mardi gras activities: one thousand five hundred dollars (\$1,500.00) base rental fee against ten (10) of gross proceeds after taxes, whichever figure is greater, computed per performance, plus a three hundred dollars (\$300.00) set up fee.
- b. General meetings, conferences, sales showings, graduations, assemblies, banquets, meal functions, dances: one thousand five hundred dollars (\$1,500.00) base rental fee per day where no admission is charged plus a three hundred dollars (\$300.00) set up fee.

(3) Exhibition hall configuration: (Floor only)

- a. Hall A & B: Consumer shows, trade shows, sales showings, expositions, exhibitions, booth displays: two thousand five hundred dollars (\$2,500.00) base rental fee per day plus a two hundred fifty dollars (\$250.00) set up fee.
 - 1. Hall A: One thousand two hundred dollars (\$1,200.00) base rental fee per day plus a one hundred fifty dollars (\$150.00) set up fee.
 - 2. Hall B: One thousand four hundred dollars (\$1,400.00) base rental fee per day plus a two hundred dollars (\$200.00) set up fee.

(4) Meeting room wing.

(5) Move in, move out, rehearsals. No additional charge if on the same day as performance or use day. One-half (1/2) of the established base rental rate if on day other than performance or use day. Activities on moving days, other than the day of the performance, shall take place only during normal business hours.

Moving activities outside of normal business hours shall take place only at the discretion and in accordance with the requirements of the Director of the Civic Center.

(6) Special rates:

- a. Non-Commercial: The non-commercial rate is seventy-five (75) percent of the base rental fee only and applies to the arena, theater and exhibition areas only.
- b. Non-profit, tax exempt, community service oriented organizations and groups operating in Terrebonne Parish and fulfilling a public purpose based in the local community whose activities would be of a public nature that would be for the benefit of and open to the general public; and local government agencies, may qualify for this non-commercial rate upon submittal and approval of the required application. Applications are available from the booking department.
 - All other rates, terms and conditions shall apply.
 - Non-commercial rates shall not apply to activities that compete with commercial events.

(7) Conditions of rental:

- a. Time used from 8:00 a.m. -- 12:00 midnight or any fraction thereof shall be defined as a usage period.
- b. Time used after contracted limits without prior understanding between the facility and the user shall be charged as follows:

Arena . . . \$500.00/per hour plus staffing and service fees Theater . . . \$250.00/per hour plus staffing and service fees Exhibition Hall . . . \$150.00/per hour plus staffing and service fees Meeting Rooms . . . \$50.00/per hour plus staffing and service fees

(8) Additional fees:

- a. Rates and set-up fees include normal lighting, temperature control, standard set up, event coordination, and janitorial services.
- b. Rates do not include staffing, equipment, box office, advertising, catering, or special services requested or required. Contact the booking department for more information on these services.

c. The rental fees listed throughout this document are further supplemented by a list of service charges and equipment fees (subject to change) which are available from the booking department.

Estimates for special labor requirements, stage hand labor and production needs are available upon request.

(9) General condition:

- a. All use of the Houma-Terrebonne Civic Center shall be permitted only after proper execution of the rental/lease contract (Authorized User Contract Agreement). The lessee is required to furnish, in an acceptable manner, any information requested by civic center management as to required facilities, special arrangements, special services, and equipment required for the appropriate presentation of the event in question.
- b. Deposits requested with any lease agreement shall be remitted at the time and in the form as prescribed by civic center management, and in the event of non-payment of said required deposits, or expiration of those dates originally determined for execution of an agreement, the civic center management may consider such tentative agreements invalid, thus vacating the originally requested date.
- c. Detailed information as to normal rental procedures and other aspects of facility usage are encompassed in the "Rental Operations Manual" available upon request from the booking department.
- d. Compliance with regulations, ordinances, laws and relevant statutes. The execution of an agreement for facility usage with the Houma-Terrebonne Civic Center further requires full compliance with all existing regulations, laws, ordinances, and statutes regarding the operation of the facility, its governing authority, the parish government, and all pertinent safety and fiscal procedures. These rules and regulations also pertain to permits and licenses required, taxes owed, liability incurred, certain flammable, pyrotechnic or dangerous materials and/or activities.
- e. Notice. The privilege, right, organization of control or preeminence of authority not herewith defined or clearly expressed in the lease agreement, rental rates document, or Rental Operations Manual shall remain in the province of the Houma-Terrebonne Civic Center and its governing authority, the parish government.
- f. Additional services. In addition, the Houma-Terrebonne Civic Center can provide at pre-agreed costs and/or fees, the following services:
 - 1. Extended box office service.
 - 2. Special catering requirements.
 - 3. Advertising and promotional assistance, media buying, specific promotional and advertising projects.
 - 4. Specialized group and event ticket sales assistance.
 - 5. Specialized production assistance, including lighting, staging, sound amplification and event direction.
- (c) Clean-up fee and equipment usage.

The Director of the Houma-Terrebonne Civic Center may allow a non-profit organization to provide its own alcoholic beverages and food at a private event that is only open to, and attended by members and guests of the non-profit organization provided the following provisions are met:

- 1) These provisions are in effect only for a total of 20 events during a calendar year on a first booked basis conditioned on available dates.
- 2) The private function or event is only open to the members and guests of the non-profit organization.
- 3) These provisions do not apply to events open to the general public including ticket sales events where tickets are sold to the general public in advance, at the door, with or without "hard tickets" by Ticketmaster, or by the organization.
- 4) Alcohol and/or food cannot be <u>SOLD</u> by the organization, its members, guests or any attendee.
- 5) The organization must have a non-rofit status and submit a FEDERAL IDENTIFICATION NUMBER signifying its non-profit status upon signing of a CIVIC CENTER CONTRACT.
- 6) The organization must have \$1,000,000.00 Host Liquor Endorsement liability insurance naming Terrebonne Parish Consolidated Government and CATERER or OPERATOR as additional insureds and have the standard \$1,000,000.00 general liability insurance.
- 7) The use of the CIVIC CENTER kitchen, supplies and/or any of its equipment are strictly prohibited.
- 8) These provisions allow individual (prepared and packaged off-site) table service only. No banquet (plated) service or buffet service allowed.
- 9) Any non-profit organization qualified under theses provisions and authorized by the director of the Houma-Terrebonne Civic Center to host a private function and provide its own food and alcoholic beverages, shall also pay a clean-up fee of \$500.00 for the whole arena, \$375.00 for half the house (Hall B) \$250.00 to the CIVIC CENTER (in addition to the normal rental fees) for clean-up fees for the labor to clean and dispose of the food and beverage items normally handled and disposed of by the in-house caterer.

The Chairman recognized Mr. Paul Rainwater, Louisiana Recovery Authority (LRA), who stated that the LRA recently was able to take about \$14 million in Hazard Mitigation Funds to help the parishes and municipalities meet their new challenge of building codes. He stated there were 15 parishes and about 42 municipalities that received ABFE Maps and, as of today, 9 of those communities have adopted ABFEs. He stated that letters will be going out to the parishes that have not adopted ABFEs because their Hazard Mitigation Funds will be reallocated based on requirements for parishes that did adopt the ABFEs. He stated that a new program allocates approximately \$595 million for critical infrastructure repair costs, which also requires the adoption of the ABFEs. He stated the LRA Board has not changed its position on the ABFEs as it relates to Hazard Mitigation funds, outside of the Road Home Program, which is a little bit different because the application is between the individual and the state and not the parish and the state.

Councilman C. Voisin stated that earlier this afternoon, a meeting took place with Mr. Rainwater, several local developers, President Schwab, and Parish Manager Blackwell. He stated that one issue that was brought up was a letter sent by Senator Landrieu taking a stand on why the communities along the gulf coast must adopt permanent maps when the maps are only temporary, but Terrebonne Parish was not sent a copy of the letter. He expressed his concerns that the way the maps have been drawn, there are properties in northwest Terrebonne Parish that are actually within the FEMA map guidelines and they classified as Class A, rather than C, like the neighboring lot might be. He said in speaking with Mr. Rainwater today, he has agreed that if Terrebonne Parish, by resolution, requests him to take some of these maps of the subdivisions and areas in question to the LRA for consideration that they may be excluded.

A discussion ensued relative to the LRA and their requirements to adopt ABFE's to receive federal funding and if there will be any room for modification of the adopted maps.

Parish President D. Schwab stated he contacted Senator Landrieu's office regarding why Terrebonne Parish was left off the list and he will probably get a call from the Senator regarding the matter.

Parish Manager B. Blackwell requested of Mr. Rainwater that when a meeting is held with LRA, FEMA, and General Powell, that Terrebonne Parish be allowed six representatives (2 Council Members, 2 Administration representatives, and 2 representatives from the development community) to attend this meeting.

The Chairman recognized Mr. Donald Landry, former Police Juror and Duval St. resident, who stated that he sent a "Letter to the Editor" on September 13, and "The Courier" exercised their editorial prerogative in that they deleted three phrases, which he feels were very important. He stated that his letter included if "The Courier" publishes this letter, in the next letter he would detail for you a much fairer way to raise the money for hurricane/drainage protection. He stated that 60% of the ad valorem taxes in Terrebonne Parish are collected from major companies out of the Parish and he is disappointed that not taxing the companies and corporations that will have the most benefit was not looked into as a financing option.

Parish Attorney Courtney Alcock stated that the ordinance addressing nuisance sign violations was amended to provide criminal penalties/fines for littering under the Parish's nuisance abatement code and provide for the Planning & Zoning Department to pick up and store the signs.
