

**“NOTICE TO THE PUBLIC”**

The Terrebonne Parish Council is seeking individuals to serve on various boards, committees, and commissions designed to maintain and improve the quality of life in our community. The agencies in need of members are governmental or quasi-governmental organizations that require people who are familiar with each agency and are willing to give of their time and talents. The Parish Council will consider at its **APRIL 28, 2021 Regular Session** meeting the following vacancies and appointments:

**RECREATION DISTRICT NO. 3A:** One expired term.

**RECREATION DISTRICT NO. 2,3:** Three (3) expiring terms on 05-31-21.

**BAYOU BLUE FIRE PROTECTION DISTRICT:** One expired term on 01-01-21.

**COTEAU FIRE PROTECTION DISTRICT BOARD:** One unexpired term due to a resignation.

**VILLAGE EAST FIRE PROTECTION DISTRICT BOARD:** One expired term on 01-01-21.

**FIRE PROTECTION DISTRICT NO. 6:** One unexpired term due to a resignation.

**DOWNTOWN DEVELOPMENT CORPORATION:** Two expiring terms (11-30-20). (One representing the Historical Society and one representing Arts and Humanities)

**TERREBONNE PARISH TREE BOARD:** One expiring term on 02-23-21 and one vacancy due to a resignation.

**CHILDREN AND YOUTH SERVICES BOARD:** Six (6) expired terms. One representing each of the following: Office of Juvenile Justice, Gulf Coast Teaching and Family Services, DHH Office of Behavioral Health, Options for Independence, Houma Police Department and a Faith-Based Organization representative.

**HOUMA AREA CONVENTION AND VISITORS BUREAU:** One unexpired term due to a resignation. (Representing a Civic Non-Profit Organization)

**SOUTH CENTRAL LOUISIANA HUMAN SERVICES AUTHORITY:** One vacancy representing the medical field (MD, RN, Public Health, School-Based Health Care or Coroner’s Office) judicial system (Judge, District Attorney’s Office or Law Enforcement).

**VETERANS’ MEMORIAL DISTRICT:** One unexpired term due to a resignation.

**PLANNING AND ZONING COMMISSION:** One unexpired term due to a resignation.

**CONSOLIDATED WATERWORKS DISTRICT NO. 1:** One unexpired term due to a resignation (District 3).

**T.A.R.C.:** Three (3) expiring terms on 05-31-21 (Two representing the membership and one representing the Parish President’s Office)

**HOUMA -TERREBONNE PUBLIC TRUST FINANCING AUTHORITY:** One expired term.

Interested individuals wishing to be appointed to a Recreation Board must be a resident of the Recreation District and be willing to attend regularly scheduled meetings to discuss and take action on matters pertaining to recreational facilities and activities therein.
