

NOTICE TO THE PUBLIC

The Terrebonne Parish Council is seeking individuals to serve on various boards, committees, and commissions designed to maintain and improve the quality of life in our community. The agencies in need of members are governmental or quasi-governmental organizations that require people who are familiar with each agency and are willing to give of their time and talents. *At an upcoming meeting of the Parish Council, individuals are scheduled to be appointed to each of the following entities:

- **Bayou Blue Fire Protection District Board:** (One vacancy) Interested individuals must be resident property taxpayers of the Bayou Blue Fire District (Terrebonne Parish side) and interested in the administration of fire protection services in the area. (*10/23/13)
- **Houma-Terrebonne Airport Commission:** (One vacancy) Interested individuals should be citizens and residents of Terrebonne Parish and should be interested and familiar with the management of the Houma-Terrebonne Airport. (*10/23/13)
- **Recreation District No. 3A Board:** (One vacancy) Interested individuals must be residents of the recreation district and be willing to attend regularly-scheduled meetings to discuss and take action on matters pertaining to recreational facilities and activities therein. (*10/23/13)
- **Recreation District No. 7 Board:** (One vacancy) Interested individuals must be residents of the recreation district and be willing to attend regularly-scheduled meetings to discuss and take action on matters pertaining to recreational facilities and activities therein. (*10/23/13)
- **Recreation District No. 10 Board:** (One vacancy) Interested individuals must be residents of the recreation district and be willing to attend regularly-scheduled meetings to discuss and take action on matters pertaining to recreational facilities and activities therein. (*10/23/13)
- **Coastal Zone Management & Coastal Restoration Advisory Committee:** (Four vacancies) Two members to be appointed as representatives of the general public, one as a representative of recreational fishermen, and one as a representative of Parish property owners. Individuals must be interested in coastal zone management issues, and must be willing to make decisions based upon information provided by the Parish's Zone Management and Restoration Department Director and Staff. - **Houma Downtown Development Corporation:** (One vacancy) Interested individuals must be citizens of Terrebonne Parish and interested in the future development of downtown Houma. (*10/23/13)
- **Houma Area Convention and Visitors Bureau** (Two vacancies) One appointee to be nominated by a private, non-profit organization whose operations relate to the tourism industry. Qualified individuals should be interested in the promotion of Terrebonne Parish to outside visitors. (*10/23/13)
- **Recreation District No. 7 Board:** (One vacancy) Interested individuals must be residents of the recreation district and be willing to attend regularly-scheduled meetings to discuss and take action on matters pertaining to recreational facilities and activities therein. (*11/6/13)
- **Houma-Terrebonne Airport Commission:** (One vacancy) Interested individuals should be citizens and residents of Terrebonne Parish and should be interested and familiar with the management of the Houma-Terrebonne Airport. (*11/20/13)
- **Houma-Terrebonne Regional Planning Commission:** (Two vacancies) Interested individuals must contact the Council Clerk's office to obtain an application to serve as a commissioner, should be resident electors of Terrebonne Parish, one of the appointees must reside within the boundaries of the City of Houma, and all applicants should be familiar with zoning and subdivision regulations.
