The agencies in need of members are governmental or quasi-governmental organizations that require people who are familiar with each agency and are willing to give of their time and talents. *At an upcoming meeting of the Parish Council, individuals are scheduled to be appointed to each of the following entities:

- **Bayou Blue Fire Protection District Board:** (One vacancy) Interested individuals must be resident property taxpayers of the Bayou Blue Fire District (Terrebonne Parish side) and interested in the administration of fire protection services in the area. (*1/8/14)
- **Coteau Fire Protection District Board:** (Two vacancies) Interested individuals must be resident property taxpayers of the Fire District and interested in the administration of fire protection services in the area. (*1/8/14)
- **Village East Fire Protection District Board:** (Three vacancies) Interested individuals must be resident property taxpayers of the Fire District and interested in the administration of fire protection services in the area. (*1/8/14)
- **Fire Protection District No. 4 Board:** (One vacancy) Interested individuals must be resident property taxpayers of the Fire District and interested in the administration of fire protection services in the area. (*1/8/14)
- **Fire Protection District No. 6 Board:** (Two vacancies) Interested individuals must be resident property taxpayers of the Fire District and interested in the administration of fire protection services in the area. (*1/8/14)
- **Fire Protection District No. 8 Board:** (Two vacancies) Interested individuals must be resident property taxpayers of the Fire District and interested in the administration of fire protection services in the area. (*1/8/14)
- **Bayou Cane Fire Protection District Board:** (One vacancy) Interested individuals must be resident property taxpayers of the Fire District and interested in the administration of fire protection services in the area. (*1/8/14)
- **Recreation District No. 8 Board:** (One vacancy) Interested individuals must be residents of the recreation district and be willing to attend regularly-scheduled meetings to discuss and take action on matters pertaining to recreational facilities and activities therein. (*2/12/14)
