

NOTICE TO THE PUBLIC

The Terrebonne Parish Council is seeking individuals to serve on various boards, committees, and commissions designed to maintain and improve the quality of life in our community. The agencies in need of members are governmental or quasi-governmental organizations that require people who are familiar with each agency and are willing to give of their time and talents. *At an upcoming meeting of the Parish Council, individuals are scheduled to be appointed to each of the following entities:

- **Bayou Blue Fire Protection District Board:** (One vacancy) Interested individuals must be resident property taxpayers of the Bayou Blue Fire District (Terrebonne Parish side) and interested in the administration of fire protection services in the area. (*5/14/14)
- **South Central Louisiana Human Services Authority Board:** (One vacancy) Interested individuals must be residents of Terrebonne Parish and have past experience in the mental health care profession. Meetings are held monthly in various areas of a six-parish region. (*5/14/14)
- **Coastal Zone Management & Coastal Restoration Advisory Committee:** (One vacancy) Member to be appointed as a representative of the general public until 10/31/15. Interested individuals must be interested in coastal zone management issues, and must be willing to make decisions based upon information provided by the Parish's Coastal Zone Management and Restoration Department Director and Staff. - **Consolidated Waterworks District No. 1 Board:** (One vacancy) Interested individuals must reside within Council District No. 5, be a qualified voter, and be willing to attend regularly-scheduled meetings until 6/24/17 to discuss and make informed decisions on matters pertaining to the Terrebonne Parish waterworks system. - **Recreation District No. 2,3 Board:** (One vacancy) Interested individuals must be residents of the recreation district and be willing to attend regularly-scheduled meetings to discuss and take action on matters pertaining to recreational facilities and activities therein. (*5/14/14)
- **Recreation District No. 4 Board:** (One vacancy) Interested individuals must be residents of the recreation district and be willing to attend regularly-scheduled meetings to discuss and take action on matters pertaining to recreational facilities and activities therein. (*5/14/14)
- **Recreation District No. 9 Board:** (One vacancy) Interested individuals must be residents of the recreation district and be willing to attend regularly-scheduled meetings to discuss and take action on matters pertaining to recreational facilities and activities therein. (*5/28/14)
- **Recreation District No. 1 Board:** (One vacancy) Interested individuals must be residents of the recreation district and be willing to attend regularly-scheduled meetings to discuss and take action on matters pertaining to recreational facilities and activities therein. (*5/28/14)
- **Consolidated Waterworks District No. 1 Board:** (Three vacancies) Interested individuals must reside within either Council District No. 3, Council District No. 7 or Council District No. 8, be qualified voters, and be willing to attend regularly-scheduled meetings to discuss and make informed decisions on matters pertaining to the Terrebonne Parish waterworks system.
