

NOTICE TO THE PUBLIC

The Terrebonne Parish Council is seeking individuals to serve on various boards, committees, and commissions designed to maintain and improve the quality of life in our community. The agencies in need of members are governmental or quasi-governmental organizations that require people who are familiar with each agency and are willing to give of their time and talents. *At an upcoming meeting of the Parish Council, individuals are scheduled to be appointed to each of the following entities:

- **Bayou Blue Fire Protection District Board:** (One vacancy) Interested individuals must be resident property taxpayers of the Bayou Blue Fire District (Terrebonne Parish side) and interested in the administration of fire protection services in the area. (*8/26/15)
- **Terrebonne Economic Development Authority (TEDA – newly reelected Board as of 8/1/15, Act. 191):** (nine vacancies) Interested individuals must be a citizen of the United States, a qualified voter residing within the boundaries of the authority, and either a proprietor, partner, or officer of a business located within the boundaries of the authority. The board shall be composed as follows: One Member appointed by the Terrebonne Parish President. Two Members, both of whom are Black or African American, appointed by the governing authority of Terrebonne Parish. Three Members appointed by the governing board of South Central Industrial Association, confirmed by the governing authority of Terrebonne Parish. Three Members appointed by the governing board of the Houma-Terrebonne Chamber of Commerce, confirmed by the governing authority of Terrebonne Parish. (*9/9/15)
- **Houma Board of Adjustments:** One expiring term on 9/1/15.) Interested individuals must be landowners and qualified voters of the urban planning district of the Parish. (*9/9/15)
- **Recreation District No. 10:** One expiring term on 9/11/15. Interested individuals must be a resident of the recreation district and be willing to attend regularly-scheduled meetings to discuss and take action on matters pertaining to recreational facilities and activities therein. (*9/9/15)
- **Terrebonne Parish Veteran's Memorial District:** Three expiring terms on 9/15/15. Interested individuals shall be a citizen of Terrebonne Parish. One nominated from a list of three names submitted by the Regional Military Museum; one nominated from a list submitted by the Regional Military Museum and appointed by the Terrebonne Parish Legislative Delegation and a resident of the parish south of the Intracoastal; and one from a list of nominees from a veterans' organization domiciled in Terrebonne Parish. (*9/9/15)
- **Terrebonne Parish Tree Board:** One vacancy. The Board's responsibility is to study, investigate, counsel and develop and/or update annually, and administer a written plan for the care, preservation, pruning, planting, replanting, removal or disposition of trees and shrubs in parks, within public rights-of-way along streets and in other public areas. (*9/9/15)
- **Recreation District No. 11 Board:** One vacancy. Interested individuals must be a resident of the recreation district and be willing to attend regularly-scheduled meetings to discuss and take action on matters pertaining to recreational facilities and activities therein. (*9/9/15)
- **Recreation District No. 4 Board:** Two expiring terms on 10/11/15. Interested individuals must be a resident of the recreation district and be willing to attend regularly-scheduled meetings to discuss and take action on matters pertaining to recreational facilities and activities therein. (*9/9/15)
- **Houma-Terrebonne Airport Commission:** One expiring term on 10/15/15. Interested individuals should be citizens and residents of Terrebonne Parish and should be interested and familiar with the management of the Houma-Terrebonne Airport (*10/7/15)
