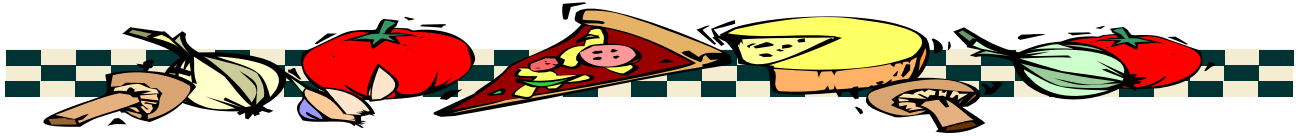

You must provide COPIES we can keep of:

- Social security cards for EVERY member living in your household. Must be paper card issued by social security office. NO PLASTIC or METAL CARDS WILL BE ACCEPTED.
- A current and valid Driver's License or Picture ID with person's name on it for everyone 18 and older in the household. Handicapped ID's WILL NOT be accepted. It cannot be an expired license or ID.
- Current proof of income for everyone in household receiving income (Ex. last 4 consecutive check stubs, 2018 social security or SSI printout), 2018 retirement letter, 2017 income tax forms if self employed, etc. If you receive unemployment we need the printout for the last 30 days of payment and must have your name on the printout.  
\*Please note: bank statements WILL NOT be accepted as proof of income\*
- Proof of residency (Ex. Bill or other piece of mail in your name at your physical address). It must have a name and address on the bill to be accepted and must be dated within the last 30 days.
