## AVAILABLE FOR REVIEW: PROPOSED UPDATES TO THE ADMINISTRATIVE PLAN FOR THE SECTION 8 HOUSING CHOICE VOUCHER PROGRAM

The Terrebonne Parish Consolidated Government's Public Housing Agency (PHA) is soliciting public review and comment on the proposed updates to the Section 8 Housing Choice Voucher Program's Administrative Plan in compliance with the Quality Housing and Work Responsibility Act of 1998 (QHWRA), the U.S. Department of Housing and Urban Development (HUD) Rule (24 CFR Part 903 and 982.54), and Public and Indian Housing (PIH) Notice 2000-43. The proposed Administrative Plan will be available for public review for a period of 30 days beginning Tuesday, July 5, 2016 and commencing on Wednesday, August 3, 2016.

The Administrative Plan establishes local policies for administration of the Section 8 Housing Choice Voucher Program in accordance with HUD requirements. The Board will be considering updates to the Administrative Plan both mandated by HUD and matters with which the PHA has discretion in order to administer local housing policies. The Administrative Plan must be available for public review and comments on the proposed Plan updates are requested and encouraged.
