INVITATION TO BIDDERS

Scaled bids will be received on July 13, 2022, by the Terrebonne Parish Animal Shelter, at the office of Milford & Associates, Inc., 1538 Polk Street, in Houma, Louisiana until 2:00 P.M. Milford and Associates, Inc. shall at that time and place publicly open the bids and read them aloud.

Vendors/Contractors have the option to submit their bids electronically or by paper copy. Each bid shall be either hand delivered by the bidder or his agent, or such bid shall be sent by United States Postal Service registered or certified mail with a return receipt requested, or shall be submitted electronically with Central Auction House (CAH). Bids shall not be accepted or taken, including receiving any hand delivered bids, on days which are recognized as holidays by the United States Postal Service.

This Project shall require a Louisiana Contractors license number for **“BUILDING CONSTRUCTION, ELECTRICAL WORK, AND MECHANICAL WORK CONSTRUCTION”**.

In accordance with Louisiana Public Bid Law, prime Bidders shall be charged a deposit of \$75.00 for one (1) set of Contract Documents, Specifications and Plans, and upon return of the complete set of Contract Documents, Specifications and Plans in good condition within 10 days from receipt of Bids, shall be refunded the full deposit.
