FOUR (4) NEW AND UNUSED CAB & CHASSIS

General information: The vehicle furnished shall be new, of current year (2023 or later) manufacture, which is of latest design and production, completely serviced and ready for operation. Any items appearing in the manufacturer's regular published specifications furnished by the Bidder are assumed to be included in the Bidder's submittal. Bidders are cautioned to read the specifications carefully, as they may include special requirements not commonly offered by the manufacturer.

Dealer shall supply the Cab & Chassis. The owner will be responsible for the installation of the dump bed. The dealer shall be required to transport the truck to the vendor contracted to install dump bed.

Whenever materials or equipment are specified or described in the Bidding Documents by using the name of a certain brand, make, supplier, manufacturer, or definite specification; the naming or specification of the item is only intended to denote the quality standard of the item desired and to convey and establish the general style, type, character and quality of material, equipment or product desired and does not restrict bidders to the specific brand, make, manufacturer, or specification named; and that equivalent products may be acceptable.

Terrebonne Parish Consolidated Government reserves the right to reduce quantities or increase quantities pending cost and budget.

Warranty:

The Cab & Chassis shall have no less than the standard factory warranty. The bidder shall be responsible for all warranty work.

Shall have battery service disconnect switch.

Lighting:

Headlights LED or halogen

Integrated Taillights: Signal, turn and brake standard LED or halogen

Backup lights standard LED of halogen and mounted on rear of chassis

Side Marker lights shall be LED or halogen

Work traffic lighting:

Controls shall be mounted inside of cab located in reach of the operator of the truck.

Flashing work lights shall be in the following locations - 2 mounted in the front grill, 1 mounted behind driver side door at base of cab, 1 mounted behind passenger side door at base of cab, LED or halogen color shall be amber / white.

Camera: Rear facing with in-cab monitoring that caters to driver situational awareness.

Fuel tank: Drivers side / left hand step type 45 gallons minimum.

Tires: Highway tread on front steering, mud, and snow on rear axles.

Factory installed heat and A/C.

Factory installed grab handles for 3-point access Both driver side and passenger.

Driver's seat shall be adjustable air ride.

Gauge cluster shall be standard for that model vehicle.

Two sets of wiring diagrams (digital accepted)

Rubber floor mats
