> Replace/Add the language in the section titled **"DELIVERY"** on page 5 with the following:

**DELIVERY:** The Notice to Proceed may be given at any time within thirty days after the effective date of the agreement, provided the Bidder meets all requirements. Upon mutual written consent by both parties, the notice to proceed may be extended. The work must be completed within **140 calendar days** after receipt of the enclosures. However, the vendor may initiate the project prior to the arrival of the enclosures and work to complete the job to the extent allowable prior to enclosure delivery. A TPCG representative will request periodic updates as to the estimated time of arrival (ETA) of the enclosures from the awarded bidder. The vendor must inform the TPCG when the enclosures arrive, at which time the 140 calendar days take effect.

Please delete/ignore all reference to Bid 23-GDRA-09 Purchase of New/Unused 12-yard Tandem Dump Trucks as it was attached in error to addendum #1.

The requirement for acknowledging any past, current, or future addenda associated with this bid is as follows: If you have already submitted your bid through Central Auction House (CAH), you must return to your submittal to acknowledge this addendum. If you have not submitted your bid, you will be prompted to acknowledge any addenda during the submittal process. Failure by a Bidder to acknowledge each individual addendum shall render your company's bid as non-responsive.
