PART I – WRITTEN CONTRACTORS QUESTIONS

PART I – Written Contractor's Questions

NOTE – The responses presented in PART I may differ from those presented in the Pre-Bid Conference. The responses in PART I are current as of the date of this Addendum and if different supersede those provided at the Pre-Bid Conference or any previous addenda.

Contractors' General Questions Received

- 1. Line post size 2-3/8" or 1.90"?
 - Response: Standard fencing details states 1.9", however actual size will need to be verified per location.
 All fencing repairs requiring line post replacement shall be replaced in-kind.
- 2. Corner/End post size 2-7/8" or 2.375"?
 - Response: Standard fencing details states 2.375", however actual size will need to be verified per location. All fencing repairs requiring corner/end post replacement shall be replaced "in-kind".
- **3.** What is the spacing for fence grounding?

Response: Vertical Posts are spaced 6-8' apart, exact spacing will need to be verified per location.

4. Fence detail shows 3 strand barb wire, For complete replacements do we replace fencing in-kind or with 3 strand barb wire?

Response: Fencing shall be repaired/replaced in-kind.

5. Page C01, Note 3, What is an apron extended outward form area being protected?

Response: Note 3 on Sheet C01 will not apply to this project.

6. Section 03-30-00 Concrete Repairs. Paragraph 6.0, B states concrete mix should be ready-mix concrete, Can sack concrete be used for smaller fence repairs or areas where concrete truck access is limited?

Response: Yes, however contractor shall submit product data for prior approval.

7. Section S-03 Trash Rake Repair. Who are the manufacturers of existing trash rakes that require repair?

Response: Duperon

8. Section 06-10-00. It appears on the drawings that some fascia boards are painted. Lumber specified in section 2.1 is pressure treated. Are we to paint replaced pressure treated lumber to match existing? If so what is the specification on primer and paint and how many coats?

Response: Fascia Boards to be repaired/replaced shall match existing. If applicable, 1 coat of exterior primer and 2 coats of paint shall be used, Sherwin Williams exterior paint or approved equal. Product data and color samples shall be submitted for approval.
