	It should read "and performing all work necessary for: TPCG CIVIC CENTER – CIVIC CENTER BLVD."				
Clarifications	- Unit Prices for Items #12 & #13 on the Unit Price Form should be Square Feet. (Attachment B)				
Questions	- Should the unit price form match the total bid? If so will there be a line item for general conditions? - Yes, the "Base Bid" items in the unit price form should match the "Base Bid Total" and the same goes for the Alternate Items. There will be no General Conditions item.				
	- Will Builders Risk be required? - Yes, Builders Risk is Required.				
	 Can you address the possible effects of driving piles and moving the rig on concrete paving? There is a good possibility that concrete will be cracked while these activities are taking place. – The contractor shall be responsible for all damages to the concrete pavement at no cost to the owner. The pavement is 6" thick. Impact driving is specified as the pile driving method for this project. Soil displacement underneath the slab and vibrations incurred from driving the piles could potentially have an affect on the surrounding concrete 				
	 Reference Unit Prices for Items #47 & #48, is there a quantity we can apply to these? The plans and specifications have more than adequate information to calculate these quantities. Reference Sheets A1.10, A6.00 & A7.02 (photos 72-75) 				
	 Sheet E1.0, note 1 to replace all conduit. This will require a substantial amount of removal and replacement of concrete paving which isn't identified on the plans. Can you clarify this will be required at all locations? - The intent of this note is to replace all conduit that is in the area of demo for each area such as the 6' x 6' demo area for the Light Pole Foundations and the 4' x 4' demo area for the RV Hookup area as shown on Sheet 10
