RECREATION DISTRICT NO. 1. BOARD: Two (2) expiring terms on 09-10-26 and 09-12-26.

(Each representing the following entities one (1) representing DCFS, one (1) representing Social Services, one (1) representing Mental Health, one (1) representing a Faith-Based Organization, and one (1) representing the Office of the District Public Defender, 32nd JDC).
