Applications must be done in person and require a valid picture ID, Social Security card, and proof of property ownership/leasing information (see requirements below).

Requirements:

For a mobile home/travel trailer is being moved onto a property:

Inspection by the Department of Planning & Zoning
(Government Tower, second floor, 985-873-6568)

Permit from the Department Planning & Zoning
(Government Tower, second floor, 985-873-6567)

For a mobile home being rented:

Rental receipt or lease bearing the tenant's name and physical address and the landlord/rental agent's name and phone number

Commercial utility services deposit amount + additional information

Electric/gas service \$50.00 per service

Requirements:

Before any service is established: Inspection by the Department of Planning & Zoning
(Government Tower, second floor, 985-873-6568)

For inside city limits:

Certificate of Occupancy from the Department of Planning & Zoning
(Government Tower, second floor, 985-873-6567)

For outside of city limits:

Certificate of Compliance from the Department of Planning & Zoning
(Government Tower, second floor, 985-873-6567)

If someone other than the business owner seeks a utility billing services on behalf of the employer/company, a written *Authorization to Act* on company stationery is required. This document must include the company's federal tax ID. Bring your valid picture ID in person to initiate the process.

GAS AND ELECTRIC RATES

Electrical

Energy cost charge for the current month is 5¢ per KWH.

ELECTRIC RESIDENTIAL

Single-Phase Meter (ER 100)	\$3.00 + 4.5¢ per KWH
Three-Phase Meter (ER 300)	\$6.00 + 4.5¢ per KWH

ELECTRIC COMMERCIAL

Small Single-Phase Meter (EC 100)	\$4.25 + 4.3¢ per KWH
Small Three-Phase Meter (EC 300)	\$7.25 + 4.3¢ per KWH
Large-Socket Meter (EC 700)	\$7.25 + 2.8¢ per KWH*
Large-Instrument Meter (EC 800)	\$28.00 + 2.8¢ per KWH*

*Customer is billed customer charge plus demand charge.

ELECTRIC DEMAND METERS (COMMERCIAL)

Electric Demand (ED 100)	\$5.50 per KVA**
Primary Service Discount (ED 200)	\$5.25 per KVA
Specialty Primary Service Discount (ED 800)	\$2.00 per KVA

**With no less than 50% of the greatest demand billed for the previous 11 months as a minimum bill.

Gas

Gas cost charge for the current month is 50¢ per 100 cubic feet.

The fee for installation and connection of gas service lines is \$2.00 per foot of service line installed up to and including one-inch lines. Additional fees may apply. Contact the Department of Utilities at 985-873-6750 with any questions.
