IN REGULAR SESSION

FEBRUARY 9, 2022

The Chairman, Mr. D. W. Guidry, Sr., called the meeting to order at 6:00 p.m. in the Terrebonne Parish Council Meeting Room. The Invocation and the Pledge of Allegiance were led by Council Member G. Michel. Upon roll call, Council Members recorded as present were: D. W. Guidry, Sr., D. Babin, D. J. Guidry, S. Trosclair, J. Navy, C. Harding, G. Michel, J. Amedée, and J. Domangue. A quorum was declared present.

Mr. C. Harding moved, seconded by Mr. J. Amedée, "THAT, the Council approve the minutes of the Regular Council Session held on January 12, 2021."

The Chairman called for a vote on the motion offered by Mr. C. Harding.

Ms. J. Domangue moved, seconded by Mr. C. Harding, "THAT, the Council approve the Accounts Payable Bill Lists for 1/31/2022 and 2/7/2022."

The Chairman called for a vote on the motion offered by Ms. J. Domangue.

- Ms. J. Domangue read a proclamation declaring the year 2022 as "Terrebonne Bicentennial Celebration Year" in Terrebonne Parish.
- Mr. Paul Labat, Bicentennial Committee Chairman, thanked the Council for their support and encouraged the public to participate in the free events throughout the year.
- Mr. J. Navy read a proclamation declaring the month of February 2022 as "Black History and Cultural Awareness Month" in Houma-Terrebonne.

Several Council Members shared their support of the proclamation and encouraged the public to learn more regarding local history.

- Mr. J. Amedée read a commendation for Mrs. Pearla Lewis acknowledging her retirement from the Waterlife Museum.
- Mrs. Pearla Lewis, commendation recipient, thanked the Council for the acknowledgment and being able to serve the Parish.
- Mr. S. Trosclair led a discussion relative to street lights and decorative lighting poles in Terrebonne Parish. He shared his experiences regarding the reporting of decorative poles for areas outside of city limits and his concerns regarding downed, energized utility poles awaiting removal by local utility companies. Mr. Trosclair suggested that more street lights along parade routes be restored to provide additional lighting for those attending the parades.

Mr. Al Galindo, Entergy Regional Customer Service Manager, gave a brief overview of the process for determining ownership of street lights for Entergy and its customers and for energizing street lights.

Discussion ensued relative to rate charges paid by Terrebonne Parish Road Lighting Districts for incandescent and LED street light fixtures.

Mr. Ernest Brown, Utilities Director, gave an update on street light repairs and upgrades following Hurricane Ida, noting that LED upgrades were completed for street lights along parade routes and assessments are being completed for decorative pole replacements.

Mr. Galindo presented statistics regarding utility service damages following Hurricane Ida. He reviewed Entergy's plans to address utility pole and street light repairs by contracting and further explained the expected completion of repairs. Mr. Galindo shared that street light bill credits would be issued for outages following the storm and that billing would be paused until those credits were issued.

Ms. Mary Fay Legnon, Entergy Customer Service Manager, gave an update on completed street light repairs in critical areas.

Discussion continued relative to reporting areas in need of street light repairs and the potential for upgrading street light fixtures while repairs are being completed.

Mr. Navy suggested that a master plan be drafted outlining preparations of potential severe weather or other disaster events in the future.

Mr. Hebert stated that the Utilities Department's mapping software can assist with locating poles and street lights in the parish then recommended that copies of the tariff regulating Entergy and the Parish's road lighting districts be forwarded to the Parish Administration for greater clarification.

- Mr. D. J. Guidry shared his concerns regarding the repair and maintenance of utility company assets and potential issues regarding voltage in specific areas of the Parish.
- Mr. C. Harding shared his support for improving street light reporting procedures and instituting a "one-call" system for addressing utility concerns.
- Mr. D. J. Guidry moved, seconded by Mr. D. Babin, "THAT the Council add-on to the agenda the following item: 'Discussion relative to Entergy, FEMA trailer connections, and street lights'."

The Chairman called for public comment on the proposed add-on.

There were no comments from the public on the proposed add-on.

The Chairman called for a vote on the motion offered by Mr. D. J. Guidry.

Mr. D. J. Guidry shared his concerns regarding energizing temporary housing units and marking of street lights in need of repair in difficult-to-access areas.

Discussion ensued relative to procedures for upgrading street lights during routine repairs and the expected completion of current repair efforts.

On Ms. Domangue's request, Mrs. Legnon clarified that Entergy customers who have been receiving bills without any energy usage should contact Entergy to final their accounts to prior to Hurricane Ida and discontinue future billings until service is restored.

The Chairman recognized Mr. Kevin Pellegrin, Sugar Plum Street resident, who shared his concerns regarding procedures for reporting street light outages and potential safety issues.

The Chairman recognized Mr. Jeff Evans, Longdale Drive resident, who shared his concerns with reporting downed/leaning poles and with millage issues. The Chairman clarified that the millages will be adjusted to compensate for the lack of service in the next tax year.

The Chairman recognized Mr. Robert Savoie, new Electrical Distribution Superintendent, who shared his resolve to improve the electrical systems of Terrebonne Parish.

Several Council Members congratulated Mrs. Legnon on her upcoming retirement and thanked her for her years of service to Terrebonne Parish and its residents.

- Ms. J. Domangue moved, seconded by Mr. J. Amedée, "THAT the Council request the Parish Administration to complete an analysis relative to upgrading all street lights in Terrebonne Parish." (*MOTION ADOPTED AFTER DISCUSSION)

RESOLUTION NO. 22-042

- 7) Civil Rights Program Administration.

AN EMERGENCY ORDINANCE TO AUTHORIZE THE RELOCATION OF TERREBONNE PARISH PRECINCT POLLING LOCATIONS DUE TO AN EMERGENCY ARISING FROM HURRICANE IDA FOR THE ELECTION OF SATURDAY, MARCH 26, 2022

SECTION I

WHEREAS, an emergency Ordinance is allowed pursuant to Terrebonne Parish Consolidated Government Charter 2-14; and

WHEREAS, an emergency declaration signed on August 26, 2021, for Hurricane Ida and recorded in the Terrebonne Parish Courthouse under COB 2646, page 676, entry No. 1634123; and

WHEREAS, elections affect the life, health, property, and safety of voting citizens of Terrebonne Parish; and

WHEREAS, an emergency ordinance is needed in order to ensure enough time is available to properly give notice of the relocations before the March 26, 2022 election; and

WHEREAS, the following listed precinct polling locations have received damage due to Hurricane Ida and are therefore unsafe to use for the Saturday, March 26, 2022 election; and

WHEREAS, TPCG wishes to relocate those polling locations in accordance with La R.S. 18:534 because the polling locations need to be changed due to an emergency caused by an act of God - Hurricane Ida; and

WHEREAS, notice of the relocation of the location of the polling places shall be published in Terrebonne Parish's Official Journal by the governing authority and the Parish Board of Election Supervisors in accordance with La. R.S. 18:535; and

WHEREAS, proper notice of the relocation of the location of the polling places shall be given, as applicable, in accordance with La. R.S. 18:536; and

WHEREAS, nothing herein shall change the Geographical boundaries of the precincts.

SECTION II

AN ORDINANCE AMENDING ORDINANCE TO AMEND SECTION 21-30(A) AND SECTION 21-31 OF CHAPTER 21, RECREATION AND PARKS, ARTICLE II PARISH GENERALLY, OF THE TERREBONNE PARISH CODE.

NOW, THEREFORE BE IT ORDAINED by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, that the following be enacted:

He presented information on the number of occupants utilizing temporary housing programs, noting that additional group sites are needed as current group sites reach capacity. On inquiry, Mr. Pulaski gave an overview of the statistics received from the temporary housing programs and highlighted that those residents still in need of temporary housing can apply at idashelteringla.com, by calling (844) 268-0301, or by visiting the Disaster Recovery Center for assistance.

- Mr. C. Harding encouraged those in need of temporary housing or other assistance to contact the disaster recovery agencies and apply before those services are no longer available.
- Mr. D. Babin encouraged individuals in need of private property demolition assistance to visit www.tpcg.org and complete the associated form for potential assistance.
