ORDINANCE NO. 9353

Upon Mr. Michel's request, the Chairman recognized Mr. Roddy Lerille, Recreation Director, who provided an update on the Terrebonne Parish Recreation District Policy and Procedure Manual currently in development.

Chief Financial Officer Kandace Mauldin clarified that sections of the manual have been completed and provided to the recreation districts for implementation and that a schedule of completion and implementation would be determined later.

Mr. Jim Wendell, Recreation Administrator, stated that a scheduling program has been purchased for scheduling recreation events and that training and setup for the system is underway with several Parish departments participating in the process. Mr. Wendell noted that recreation districts are being contacted to update facility information as available. He then gave an overview of procedures to be followed once training is completed. The Chairman recognized Ms. Darlene Williams, a Linda Ann Avenue resident, who addressed the Council relative to the application form for requesting residential demolition assistance following Hurricane Ida. She completed the application form but had concerns regarding specific details on the application.

Planning and Zoning Director Christopher Pulaski gave a brief overview of the FEMA program to provide residential demolition assistance through the Solid Waste department. He noted that data is being collected through the application process to assess the types of assistance needed.

The Chairman recognized Mr. Jason Serrano, Terrebonne Parish Tree Board Chairman, who invited the public to attend the 16th Annual Tree Give-away on Saturday, March 19, 2022 beginning at 9:00 a.m. at the Terrebonne Parish Main Branch Library.

Several Council Members shared their support of the event and the Tree Board's efforts of the Tree Board providing trees for Terrebonne Parish.

The Chairman called for a report on the Budget and Finance Committee meeting held on 03/07/22, whereupon the Committee Chairman, noting ratification of minutes calls public hearings on Wednesday, March 23, 2022, rendered the following:

BUDGET & FINANCE COMMITTEE

MARCH 7, 2022

The Chairman, Mr. Carl Harding, called the Budget & Finance Committee meeting to order at 5:30 p. m. in the Terrebonne Parish Council Meeting Room. The Invocation and the Pledge of Allegiance were led by the Chairman. Upon roll call, Committee Members recorded as present were: D. J. Guidry, S. Trosclair, C. Harding, G. Michel, J. Amedée, J. Domangue, D. W. Guidry, Sr., and D. Babin. A quorum was declared present.

TOHSEP Director Earl Eues presented statistics on Terrebonne Parish's current COVID-19 cases, the number of tests completed, death statistics, hospitalizations, and vaccine distributions.

Discussion ensured relative to COVID-19 home test kits and their impact on clinical statistics regarding positive cases.

Mr. Eues noted that self-service laundry trucks were operational in the Dulac and Chauvin areas and provided an update on FEMA assistance data and SBA assistance statistics.

Planning and Zoning Director Christopher Pulaski provided an update regarding base camp occupants and temporary housing residents. He noted several group sites under development for temporary housing.

Discussion continued relative to plans for temporary housing residents and hurricane preparedness.

Upon Mr. D. J. Guidry's request, Mr. Pulaski gave an overview regarding the Terrebonne Parish's Residential Demolition Program and funding available for reconstruction and demolition projects. He encouraged the public to visit the parish's website or contact the Solid Waste Department regarding the program.

Upon Mr. D. W. Guidry's request, Mr. Eues noted that storm debris pickup is ongoing with plans underway to allow the Parish to collect storm debris along state highways.

Upon Mr. Michel's inquiry, Chief Financial Officer Kandace Mauldin clarified that the agreement would be executed pending a budget amendment. (***RESOLUTION ADOPTED AFTER DISCUSSION**)

RESOLUTION NO. 22-078

A RESOLUTION TO AUTHORIZE THE PARISH PRESIDENT TO EXECUTE AN INTERGOVERNMENTAL AGREEMENT ON BEHALF OF TERREBONNE PARISH CONSOLIDATED (TPCG) GOVERNMENT WITH TERREBONNE LEVEE AND CONSERVATION DISTRICT (TLCD) TO FUND TLCD'S LEVEE PROJECTS IN DULARGE AND AT THE HOUMA NAVIGATIONAL LOCK WITH CAPITAL OUTLAY FUNDS.

WHEREAS, the "Local Services Law," La. R.S. 33:1321, *et seq.*, provides that any parish or political subdivision of the state may make agreements among themselves to engage jointly in the construction or improvement of any public project or improvement provided that at least one of the participants to the agreement is authorized by law to complete the undertaking; and

WHEREAS, LA R.S. 38:329 and 33:1236 specifically authorize TLCD and TPCG to enter into agreements of this nature; and

WHEREAS, TPCG is a Home Rule Charter local government and is granted the liberally construed "right and authority to exercise any power and perform any function necessary, requisite or proper for the management of its affairs" and "to promote, protect, and preserve the general welfare, safety, health, peace and good order of the parish," not denied by the Charter, by general law, or inconsistent with the Constitution, per Louisiana Constitution Articles VI §§ 5-6 and Terrebonne Parish Charter Sections 1-01, 1-05, 1-06, and 8-08; and

WHEREAS, TLCD has been granted by the Louisiana Legislature certain rights, powers, and duties, including but not limited to establishing, constructing, operating, or maintaining flood control works, as they relate to hurricane protection, tidewater flooding, saltwater intrusion, and conservation, in addition to all other rights, powers and duties provided by law; and

WHEREAS, the TPCG has been granted by the Louisiana Legislature certain, rights, powers, and duties to establish, construct, operate, and maintain flood control works; and

WHEREAS, on certain levee, drainage, and flood protection projects TPCG works directly and cooperatively with the TLCD on projects that are of mutual benefit, and overlap each agency's authority in an effort to provide additional flood protection to the residents of Terrebonne Parish; and

WHEREAS, \$3,000,000 in State Capital Outlay funds were allocated to TPCG for maintenance, planning and construction of levees; and

WHEREAS, in furtherance of these mutual goals, TPCG wishes to provide funding that funding to TLCD for the maintenance, planning and construction of levees and flood control projects more fully identified as follows:

- A levee located on the west side of Dularge, known as the Lower Dularge West Levee Project, and the structures therein;
- A levee located on the east side of Dularge, known as the Lower Dularge East Levee Project, and the structures therein;
- Improvements and/or armoring of flood control works on the east side of the Houma Navigational Lock Project site; and

WHEREAS, the construction of these flood control projects by TLCD will provide flood protection to the Dularge community and Terrebonne Parish residents, and

NOW THEREFORE BE IT RESOLVED by the Terrebonne Parish Council on behalf of the Terrebonne Parish Consolidated Government that the Parish President is authorized to execute on behalf of the TPCG the Intergovernmental Agreement attached to and incorporated in this resolution, or an agreement substantially similar, provided the proper budget amendment is adopted by this Council, and subject to approval by the TPCG legal department, for the purposes set forth herein.
