MAY 25, 2022

The Chairman, Mr. D. W. Guidry, Sr., called the meeting to order at 6:15 p.m. in the Terrebonne Parish Council Meeting Room. The Invocation and the Pledge of Allegiance were led by Mr. J. Navy. Upon roll call, Council Members recorded as present were: J. Amedée, J. Domangue, D. W. Guidry, Sr., D. Babin, D. J. Guidry, S. Trosclair, J. Navy, C. Harding, and G. Michel. A quorum was declared present.

Mr. D. J. Guidry moved, seconded by Mr. S. Trosclair, "THAT, the Council approve the minutes of the Regular Council Session held on April 27, 2022."

ORDINANCE NO. 9374

BE IT ORDAINED by the Terrebonne Parish Council of the Parish of Terrebonne, Louisiana, in a public meeting held on <u>May 25, 2022</u>, which meeting was conducted in accordance with the Open Meetings Law and the additional requirements of Article VII, Section 23(C) of the Louisiana Constitution and R.S. 47:1705(B), that the taxing district voted to increase the millage rate(s) but not in excess of the prior year's maximum rate(s) on all taxable property shown on the official assessment roll for the year <u>2022</u>, and when collected, the revenues from said taxes shall be used only for the specific purposes for which said taxes have been levied. Said millage rate(s) are:

Adjusted Rate <u>2022</u> Levy

Parish Tax – Alimony (Inside) 1.49 Mills 1.51 Mills

The Chairman declared the ordinance adopted on this the 25th day of May 2022.

Parish Manager Mike Toups gave a presentation regarding the Elliot Jones Pump Station Project. Mr. Toups clarified that Entergy would be providing power to the station with two backup generators included as part of the project.

Discussion ensued relative to Hanson Canal operations and pump usage to address potential flooding.

Solid, Hazardous, and Recycling Waste Director Clay Naquin gave a presentation regarding the Parish's plans for the 2022 grass cutting season and solid waste operations. Upon request, he clarified that the State of Louisiana was responsible for grass cutting on state highways and that it would be cost-inefficient for the Parish to take on those responsibilities at this time.

Discussion ensued relative to addressing tall grass, vegetation, and litter concerns across the parish and the implementation of a Parish mobile application to assist with reporting those concerns.

Several Council Members suggested coordination with state efforts to address tall grass and other vegetative concerns.

- Mr. D. Babin requested that items be placed on an upcoming agenda regarding updates on the Houma Generating Station and on the Buquet Bridge.
- Mr. G. Michel requested that an item be placed on an upcoming agenda regarding the maintenance of the lateral ditches in Terrebonne Parish.

The following resolution was offered by <u>MR. G. MICHEL</u>, and seconded by <u>MR. J.</u>
<u>AMEDĖE</u> of the Terrebonne Parish Council as successor to the North Terrebonne Recreation District:

RESOLUTION PROCES VERBAL NO. 22-131

A RESOLUTION OF THE PARISH OF TERREBONNE, STATE OF LOUISIANA AS SUCCESSOR GOVERNING AUTHORITY OF THE NORTH TERREBONNE RECREATION DISTRICT PROVIDING FOR CANVASSING THE RETURNS AND DECLARING THE RESULTS OF THE SPECIAL ELECTION HELD WITHIN THE BOUNDARIES OF THE DISTRICT, TERREBONNE PARISH, STATE OF LOUISIANA, ON MARCH 26, 2022, TO AUTHORIZE THE LEVY AND COLLECTION OF THE SPECIAL TAX AUTHORIZED THEREIN.

BE IT RESOLVED by the Terrebonne Parish Council, acting as the successor governing authority (the "Governing Authority") of North Terrebonne Recreation District, Parish of Terrebonne, State of Louisiana (the "District") that:

Section 1. Canvass. This Governing Authority does now proceed in open and public session to examine the official tabulations of votes cast at the special election held in the District on **Saturday, March 26, 2022,** to authorize the levy and collection of a new special tax and dedicate the revenues derived from that special tax therein and said Governing Authority does further proceed to examine and canvass the returns and declare the results of the special election.

Section 2. Procès Verbal. A *Procès Verbal* of the canvass of the returns of said election shall be made and a certified copy shall be forwarded to the Secretary of State, Baton Rouge, Louisiana, and the Clerk of Court and *Ex-Officio* Recorder of Mortgages in and for the Parish of Terrebonne, who shall record the same in their respective offices as required by law; and another copy thereof shall be retained in the archives of this Governing Authority.

Section 3. <u>Promulgation of Election Results.</u> The results of said election shall be promulgated by publication in the manner provided by law.

Section 4. <u>Conflicting Resolutions</u>. All resolutions or parts thereof, in conflict herewith are hereby repealed.

Section 5. <u>Electronic Signatures.</u> The Governing Authority consents and agrees to the execution of documents by electronic signature in accordance with the Louisiana Uniform Electronic Transactions Act (La. Rev. Statutes 9§2601, et seq.) and electronically executed documents are deemed binding and legal on all parties to the extent allowed by the provisions of that act.

The polling places above specified being the only polling places designated at which to hold the said election, it was therefore shown that for **DISTRICT 1** there was a total of 711 votes cast **AGAINST** the Proposition and a total of 290 votes cast **IN FAVOR OF** the Proposition, as herein above set forth, and that there was a majority of **71.03%** votes cast **AGAINST** the Proposition as hereinabove set forth and the Proposition **FAILED**.

The polling places above specified being the only polling places designated at which to hold the said election, it was therefore shown that for **DISTRICTS 2 -3** there was a total of 1,014 votes cast **IN FAVOR OF** the Proposition and a total of 858 votes cast **AGAINST** the Proposition, as herein above set forth, and that there was a majority of **54.17%** votes cast **IN FAVOR OF** the Proposition as hereinabove set forth and the Proposition **PASSED**.

AN ORDINANCE TO AUTHORIZE THE ACQUISITION OF PROPERTY, SITES AND/OR SERVITUDES REQUIRED TO PROVIDE A PUBLIC BOAT LANDING ADJACENT TO BAYOU PETIT CAILLOU THAT FACILITATES AND PROMOTES BOATING, FISHING AND HUNTING THEREBY PROMOTING THE QUALITY OF LIFE IN TERREBONNE PARISH AND BY ALSO PRESERVING THE PUBLIC'S ACCESS TO TERREBONNE PARISH'S WATERWAYS; AUTHORIZE THE PARISH PRESIDENT TO EXECUTE ANY AND ALL DOCUMENTS NECESSARY TO ACQUIRE SITES, PROPERTY AND/OR SERVITUDES FOR THE SAID PURPOSES; AND TO PROVIDE FOR OTHER MATTERS RELATIVE THERETO.

The Chairman called for a report on the Public Services Committee meeting held on 05/23/22, whereupon the Committee Chairman, rendered the following:

PUBLIC SERVICES COMMITTEE

MAY 23, 2022

The Chairman, John Amedée, called the Public Services Committee meeting to order at 5:30 p.m. in the Terrebonne Parish Council Meeting Room. The Invocation and the Pledge of Allegiance were led by the Chairman. Upon roll call, Committee Members recorded as present were: J. Amedée, J. Domangue, D. W. Guidry, Sr., D. Babin, D. J. Guidry, S. Trosclair, C. Harding, and G. Michel. Committee Members recorded as absent were: J. Navy. A quorum was declared present.

The Chairman read a letter from Mr. J. Navy advising of his potential absence from the evening's proceedings.

TOHSEP Director Earl Eues presented statistics on Terrebonne Parish's current COVID-19 cases, the number of tests completed, death statistics, hospitalizations, and vaccine distributions. He encouraged the public to begin their hurricane planning and noted plans to provide sheltering and/or evacuations for temporary housing residents in response to severe weather events. Upon request, Mr. Eues clarified that information will be distributed across multiple media outlets throughout the hurricane season through television interviews, news releases, and other formats.

Upon Mr. Babin's request, Planning and Zoning Director Chris Pulaski encouraged residents who have received suspicious notices regarding payment for temporary housing units to first contact the Planning Department and confirm the validity of the notice with a FEMA agent before paying.

Upon Mr. Michel's request, Mr. Eues stated that the floodgate damaged during Hurricane Ida would be operational before the start of hurricane season, but additional time would be needed to fully correct the damage caused.

Mr. Pulaski provided an update on temporary housing programs in the parish, noting a number of transitions taking place with residents no longer needing their temporary housing units. He noted that those units that are being decommissioned due to transitions are being refurbished to be reused by other program applicants.

Upon Mr. Michel's inquiry, Mr. D. W. Guidry, Sr. reported that Entergy was not on schedule to complete street light repairs in the parish due to supply chain issues and that a new date of completion would be provided to the Council soon.

Upon Ms. Domangue's request, Chief Financial Officer Kandace Mauldin clarified that no demolitions have been completed through the FEMA assistance program at this time and that an update on the program would be provided at a later date.

Mr. G. Michel moved, seconded by Ms. J. Domangue, "THAT the Public Services Committee discuss with possible action fireworks in Terrebonne Parish and their proximity to residential structures."

At the Chairman's request, Parish Attorney Julius Hebert shared that any complaints regarding fireworks were likely received by local law enforcement agencies and that he could solicit pertinent information regarding fireworks from those agencies and report back to the Council if requested.
