JUNE 09, 2021

The Chairman, Mr. D. W. Guidry, Sr., called the meeting to order at 6:00 p.m. in the Terrebonne Parish Council Meeting Room. Councilwoman J. Domangue lead the Invocation, followed by the Pledge of Allegiance.

Upon roll call, Council Members recorded as present were: S. Trosclair, J. Navy, C. Harding, G. Michel, J. Amedée, J. Domangue, D. W. Guidry, Sr., D. Babin, and D. J. Guidry. A quorum was declared present.

Mr. D. Babin moved, seconded by Mr. D. J. Guidry, "THAT, the Council approve the minutes of the Regular Council Session held on May 12, 2021."

The Chairman called for a vote on the motion offered by Mr. D. Babin.

The Chairman declared the motion adopted.

The Chairman announced that Agenda Item 1A. – "COMMENDATION-Acknowledging and commending Houma Fire Chief Keith Ward for his years of service to the Houma Fire Department and Terrebonne Parish Consolidated Government" – will be placed on a future agenda.

Parish Manager Mike Toups presented the drainage and pump station report. He proceeded to provide the Council with an update on the following: a final review of the claim has been completed and the insurance adjusters have determined that \$88,600.00 would be issued for the repairs to the PP-01 Enterprise Marine/Menard Road Pump Station. He added that Administration has requested that the insurance adjusters reinspect the pump for possible contamination. Mr. Toups continued stating that the pump has been repaired and the D70 Gator Court pump station and the hydraulics are scheduled to be completed by the end of the week; that parts for the D-35 Gibson Recreation pump station have been received, replaced, and the installation is scheduled to be completed by the end of the week; and that a pump has been put at the D-45 Tiger Bayou pump station due to a broken shaft and a temporary pump has been installed.

Mr. Toups presented a PowerPoint presentation on the St. Louis Canal Road Pump Station. He presented visuals of the hydraulic power unit being installed and the ditches surrounding the pump station after Forced and Gravity Drainage thoroughly cleaned them. He

continued that this would assist in stopping flash flooding in the Broadmoor/Lisa Park neighborhoods.

Mr. Jim Mitchell, resident of 215 Guidry St., approached the Council relative to flash flooding and the Texas Gulf Road pump station.

Councilman S. Trosclair stated that the Drainage Department is considering the reinstallation of a valve system to help regulate drainage in the area.

Parish Manager Mike Toups assured Mr. Mitchell that Administration will look into a solution for this issue.

Discussion ensued relative to current drainage issues throughout the Parish and possible solutions to this problem.

Mr. Toups added that once the Parish obtains control of the Hanson Canal Pump Station in order to pump down the Chacahoula Basin and the Elliot Jones Pump Station is completed, they will be able to provide relief for the residents in the surrounding areas.

Mr. D. Babin moved, seconded by Mr. G. Michel, "THAT, the Council open public hearings at this time."

Mr. Floyd Bergeron, resident of 201 Kellie Dr., addressed the Council relative to his opposition to the aforementioned ordinance being adopted and requested that his neighborhood be exempt from the ordinance, like the City of Houma.

Mr. G. Michel moved, seconded by Mr. J. Amedée, "THAT, the Council grant Mr. Bergeron an additional minute to conclude his comments."

The Chairman called for a vote on the motion offered by Mr. G. Michel.

Upon questioning by Councilman J. Amedée, Council Clerk Suzette Thomas explained that revised copies of the ordinances have been distributed in order to include the Parish Manager as a designated signer.

Parish Attorney Jules Hebert informed the Council that the Home Rule Charter, an Attorney General's opinion, and Case Law, indicates that the Parish President has the authority to designate the Parish Manager/Chief Administrative Officer to sign documents on his behalf.

Several council members requested clarity on the Parish Manager's responsibility and authority.

Councilman G. Michel requested that the Sheriff's Office strictly monitor and enforce the times mandated in the aforementioned ordinance regarding personal firework use.

Planning and Zoning Director Chris Pulaski stated that the revisions clarify the hours for the public display of fireworks, the date and time firework sales within the Parish can be made, and includes language pertaining to the certificate of insurance for liability.

The Chairman requested that Administration thoroughly educate the public before the fourth of July regarding when and where fireworks can be discharged in Terrebonne Parish. (*ORDINANCE ADOPTED AFTER DISCUSION)

ORDINANCE NO. 9265

TO AMEND CERTAIN PORTIONS OF SECTIONS 8-2 AND 8-3 OF THE TERREBONNE PARISH CODE OF ORDINANCES REGARDING THE USE, SALES, AND PERMIT REQUIREMENTS OF CERTAIN APPROVED FIREWORKS DURING SPECIFIED HOLIDAYS IN TERREBONNE PARISH

WHEREAS, Section 2-11 of the Terrebonne Parish Home Rule Charter requires an ordinance to amend or repeal previous Ordinances; adopt or amend an administrative code; and establish a rule or regulation imposing fines or other penalties; and

WHEREAS, the general public has expressed an interest in enjoying fireworks through consumer use and public display in celebration of certain holidays; and

WHEREAS, Revised Statutes Title 51, Section 660 authorizes local governing authorities to regulate sale, use, and possession of fireworks; and

WHEREAS, Council Ordinance No. 9195 was adopted establishing regulations regarding the public display, use, and sales of fireworks in Terrebonne Parish; and

WHEREAS, Staff, during the implementation of aforementioned ordinance, identified certain areas of confusion or conflict and seeks to clarify these areas;

NOW THEREFORE, BE IT ORDAINED by the Terrebonne Parish Council on behalf of the Terrebonne Parish Consolidated Government that:

SECTION I

Chapter 8, Article I, Section 2 of the Terrebonne Parish Code shall be amended, are hereby amended (using strikethrough to indicate deletions and underlining to indicate additions) and same are hereby adopted to read as per the attached Exhibit A.

SECTION II

Any section, clause, paragraph, provision, or portion of these regulations found to be invalid is severable, and shall not affect the validity of the whole.

EXHIBIT A

Sec. 8-3. Fireworks; sale prohibited; exception; definitions; penalty.

- (a) It shall be unlawful for any individual, firm, partnership, corporation, or other entity to possess, sell, trade, exchange, barter or in any other manner dispose of any item of fireworks within Terrebonne Parish, except as specifically provided in this article, it being the intention of this section to prohibit the sale of fireworks whatsoever within the City of Houma:
 - (1) Approved vendors may engage in sales of any kind ten (10) days in advance of any approved day where the discharging of fireworks by the general public is permitted in this article, and sales shall cease on the last day of the permitted days of consumer use listed in section 8-2(b)(1).

Permissible items of fireworks may be sold by approved vendors at retail beginning at 12:00:00 pm June 16th until 11:59:59 pm July 5th and beginning at 12:00:00 pm December 15th until 11:59:59 pm January 1st of each calendar year.

- (b) All retail vendors shall receive a permit from the parish (parish vendor's permit) at least the day before the sales period begins. Fees shall be set in accordance with R.S. 51:659. Parish vendor's permits shall expire on January 1 of the year following its issuance on the day following the corresponding fireworks event at 11:59:59pm. Vendors operating without a Pparish permit shall be ordered to immediately cease operations.
- (c) In addition to the retail vendor's permits required by the Pparish and the State Ffire Mmarshal, wholesale and retail sellers of permissible fireworks shall hold a Terrebonne Parish occupational license, provide proof of general liability insurance of at least one million dollars (\$1,000,000) with an excess liability policy of five four million dollars (\$54,000,000.00) upon application of a permit to the Pparish, naming Terrebonne Parish Consolidated Government and the Terrebonne Parish Sheriff's Office as additional insured and provide a waiver of subrogation in favor of Terrebonne Parish Consolidated Government and the Terrebonne Parish Sheriff's Office and meet all other requirements of a business entity involved in permanent or temporary commercial trade within Louisiana.
- (d) It shall be unlawful for a lawfully approved fireworks vendor to sell fireworks to:
 - (1) Persons under the age of eighteen (18). Failure of a vendor to require approved photo identification prior to completing a sale shall result in revocation of vendor's parish occupational license;

- (2) Persons who are intoxicated;
- (3) Persons who are known to be irresponsible.
- (e) No vendor shall sell, barter, convey, possess, dispose of, or use fireworks prohibited by federal or state law, including but not limited to:
 - (1) Friction fireworks with white or yellow phosphorous and explosives;
 - (2) Cherry bombs, tubular salutes, two-inch American-made salutes, firecrackers with casings the external dimensions of which exceed one and one-half (½) inches in length or one-quarter (¼) of an inch in diameter, repeating bombs, aerial bombs, torpedoes which exceed three-eighths (¾) of an inch in diameter, Roman candles larger than ten ball, and sky rockets larger than six (6) ounces;
 - (3) Only class "C" fireworks as defined in section 8-2(d) shall be sold, transferred, and distributed and/or marketed for consumer use.
- (f) Vendors shall comply with employment, health, sales, storage, display, and disposal laws and regulations in accordance with state law, federal law, requirements of the state fire marshal, and all pertinent parish ordinances. Periodic inspections of each retail stand shall be conducted throughout the permitted sales period. Vendors shall comply with TPCG building codes.
- (g) Vendors shall adhere to signage regulations set forth as follows:
 - (1) Upon issuance of a sign permit, parish vendor's permit holders shall be allowed one (1) seasonal on-premises sign, not to exceed four (4) feet by eight (8) feet, to be posted at the retail location. All signs shall require a sign permit from Terrebonne Parish and shall adhere to all applicable building codes and requirements associated with a sign permit.
 - (2) Sign permit holders may also post off-premises signage. Off-premises signs shall adhere to the signage requirements of the zoning district at the retail location, Terrebonne Parish, and the State of Louisiana Department of Transportation and Development, and other regulations.
 - (3) All signage shall be promptly removed within ten (10) days of each sales period.
- (h) Violation of this section is a misdemeanor punishable by a fine of not more than five hundred dollars (\$500.00) and/or six (6) months in jail. A vendor who violates any provision of this section shall be subject to revocation or suspension of his permit.
- (i) Subject to compliance with federal and/or state laws, nothing contained herein shall in any way restrict, prohibit, or discourage manufacturing, wholesale trade, and distribution to the fireworks industry within Terrebonne Parish.

ORDINANCE NO. 9266

AN ORDINANCE AUTHORIZING THE PARISH PRESIDENT TO ENTER INTO AND TO RATIFY A COOPERATIVE ENDEAVOR AGREEMENT WITH THE HOUMA DOWNTOWN DEVELOPMENT CORPORATION ("DDC"), DOWNTOWN BUSINESS ASSOCIATION OF HOUMA, LTD ("DTBA"), TERREBONNE PARISH CONSOLIDATED GOVERNMENT ("TPCG") AND HOSPITAL SERVICE DISTRICT #1 OF THE PARISH OF TERREBONNE ("TGMC") FOR THE PURPOSE OF DEVELOPING AND OPERATING A FARMER'S MARKET AT THE DOWNTOWN MARINA CALLED THE MARKET AT THE MARINA; AND TO PROVIDE FOR RELATED MATTERS THERETO

WHEREAS, Article VII, Section 14 of the Louisiana Constitution provides that, "[F]or public purpose, the state and its political subdivisions or political corporations may engage in cooperative endeavors with each other, with the United States or its agencies, or with any public or private corporation or individual"; and

WHEREAS, TPCG, DDC, DTBA and TGMC are working together to develop a healthy farmer's market in close proximity to TGMC's campus, at the Downtown Marina, for a public purpose that meets the healthy lifestyle needs of all of the citizens of the Parish of Terrebonne; and

WHEREAS, TPCG, DDC DTBA and TGMC envision the Market at the Marina encouraging healthier lifestyles through physical activity and healthy food options for the citizens of Terrebonne Parish; and

WHEREAS, The Market at the Marina, in accordance with the initial plan or proposal, will be open on the first Saturday of every month from 8:00 AM to 12:00 PM, and it will provide a source of fresh fruits, vegetables, and local goods to Terrebonne Parish Residents; and

WHEREAS, Entering into this cooperative endeavor agreement for the public purpose of promoting the general health of the community; and

WHEREAS, the Council authorizes the Parish President to enter into such a cooperative endeavor agreement by Resolution No. 21-181 on April 26, 2021 and a Cooperative Endeavor Agreement in connection therewith was entered into with an effective date of April 27, 2021; and

WHEREAS, out of an abundance of caution and since property of TPCG is being used and/or will be used in connection with the Cooperative Endeavor Agreement, Parish Administration respectfully requests the Council to approve this ordinance authorizing the Parish President, Gordon E. Dove, to execute a Cooperative Endeavor Agreement by and between the Houma Downtown Development Corporation ("DDC"), Downtown Business Association of Houma, Ltd. ("DTBA"), Terrebonne Parish Consolidated Government ("TPCG") and Hospital Service District #1 of the Parish of Terrebonne ("TGMC"), for developing and operating a Farmer's Market at the Downtown Marina called the Market at the Marina and to hereby ratify the Cooperative Endeavor Agreement entered into with an effective date of April 27, 2021; and

NOW THEREFORE BE IT ORDAINED by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, that the Parish President, Gordon E. Dove, be authorized to execute the Cooperative Endeavor Agreement by and between the Houma Downtown Development Corporation ("DDC"), Downtown Business Association of Houma,

Ltd. ("DTBA"), Terrebonne Parish Consolidated Government ("TPCG") and Hospital Service District #1 of the Parish of Terrebonne ("TGMC") for the developing and operating a farmer's market at the Downtown Marina called the Market at the Marina and that the Cooperative Endeavor Agreement entered into in connection with the foregoing with an effective date of April 27, 2021.

Mr. Arnold Adams, resident of 161 Bon Jovi Blvd. read a letter on behalf of the Gray Improvement Committee stating their opposition to the merger of Recreation Districts 1, 2-3, 8, and 9.

Mr. G. Michel moved, seconded by Ms. J. Domangue, "THAT, the Council close the aforementioned public hearing."

The Chairman called for a vote on the motion offered by Mr. G. Michel.

Councilman C. Harding acknowledged former Council Member Wayne Thibodeaux who was in attendance at the evening's proceedings.

Upon questioning, Chief Financial Officer Kandace Mauldin clarified that all four Recreation Districts must approve the proposition before it can move forward. She continued that the language will be clarified on the proposition before it is presented to the voters. (*ORDINANCE ADOPTED AFTER DISCUSSION)

ORDINANCE NO. 9267

AN ORDINANCE CREATING THE "NORTH TERREBONNE RECREATION DISTRICT;" DEFINING THE BOUNDARIES AND THE GOVERNING AUTHORITY THEREOF; IN ACCORDANCE WITH LA. R.S. 33:4562 ET SEQ REGARDING RECREATION DISTRICTS, CREATION BY PARISHES; CORPORATE STATUS, POWERS AND DOMICILE, AND PROVIDING FOR OTHER MATTERS IN CONNECTION WITH THE FOREGOING.

WHEREAS, Louisiana Constitutional Article VI §19 and La. R.S. 33:4562 et seq (collectively, the "Act") authorizes and empowers any parish in the state upon its own initiative to form and create a recreation district and said district shall constitute a body corporate and shall have the power and right to incur debts and enter into contracts and to do and perform any and all acts in its corporate name which are necessary or proper for carrying out the objects and purposes for which the recreation district is created; and

WHEREAS, the Parish of Terrebonne, State of Louisiana (the "Parish"), acting through the Terrebonne Parish Council (the "Council"), acting as its governing authority of the Parish, desires to avail itself of the Act to create a recreation district for the object and purpose of owning and operating playgrounds and other facilities; or generally to engage in activities which would promote recreation and related activity designed to encourage recreation and promote the general health and well being of youths; and

NOW THEREFORE, BE IT HEREBY ORDAINED by the Terrebonne Parish Council, State of Louisiana, acting as the governing authority of the Parish of Terrebonne, State of Louisiana, that:

SECTION 1. All of the above "Whereas" clauses are adopted as part of this ordinance.

SECTION 2. <u>Creation of District</u>. Under the authority of the Article there is hereby created a recreation district within the Parish, to be named the "North Terrebonne Recreation District, Parish of Terrebonne, State of Louisiana," having the geographical boundaries set forth in **Exhibit A** attached hereto that is hereby incorporated in and made a part of this Ordinance, all pursuant to the Act.

SECTION 3. Governing Authority and Power. The Council herein appoints all members of the Council to serve in the limited capacity as the interim governing authority of the District.

SECTION 4. Termination of District. If the registered voters within the boundaries of each of Terrebonne Recreation District No. 1, No. 2-3, No. 8 and No. 9 fail to approve *ad*

valorem taxes for the purpose of providing financial support of the operation and capital improvements for the District on or before December 31, 2021, the District created herein shall terminate by operation of law and sunset on December 31, 2021 without any further action by the Council or the governing authority of the District.

SECTION 5. <u>Authorization of Officers</u>. The Chairman and the Council Clerk the Governing Authority are hereby authorized, empowered and directed to do any and all things necessary and incidental to carry out the provisions of this ordinance.

SECTION 6. Severability. If any provision of this ordinance shall be held to be illegal or invalid, such illegality or invalidity shall not affect any other provision of this ordinance, but this ordinance shall be construed and enforced as if such illegal or invalid provisions had not been contained herein. Any constitutional or statutory provision enacted after the date of this ordinance which validates or makes legal any provision of this ordinance which would not otherwise be valid or legal, shall be deemed to apply to this ordinance.

SECTION 7. Conflicts. All ordinances or resolution, or parts thereof, in conflict herewith are hereby repealed.

SECTION 8. Publication: Effective Date. This ordinance shall be published one time in the official journal of the Parish as soon as practical and shall become effective immediately or at the earliest possible date provided by law.

- E. An ordinance to amend the 2021 Adopted Operating Budget, 5-Year Capital Outlay Budget, and Budgeted Positions of the Terrebonne Parish Consolidated Government for the following items and to provide for related matters:

ORDINANCE NO. 9269

AN ORDINANCE TO UPDATE AND RESTRUCTURE CHAPTER 21, ARTICLE V OF THE TERREBONNE PARISH CODE ON RECREATION DISTRICTS BY AMENDING SECTION 21-90 TO INCLUDE BUDGETING FOR THE RECREATION DISTRICTS AND ENACTING SECTIONS 21-94 THROUGH 21-98 TO PROVIDE CONSISTENCY THROUGHOUT THE RECREATION DISTRICTS

WHEREAS, Section 1–06 of the Home Rule Charter for the Parish of Terrebonne provides that the parish government shall have the right, power and authority to pass all ordinances requisite or necessary to promote, protect and preserve the general welfare, safety, health, peace and good order of the parish, including, but not by way of limitation, the right, power and authority to pass ordinances on all subject matter necessary, requisite or proper for the management of the parish affairs, and all other subject matter without exception, subject only to the limitations that the same shall not be inconsistent with the Constitution or expressly denied by the general law applicable to the parish; and

WHEREAS, in an effort to update recreation procedures in Terrebonne Parish as it pertains to the current usage and millages of all recreation districts, the maintenance and usage of facilities, and TPCG operated recreation programs in accordance with Chapter 21, "Recreation and Parks" of the Terrebonne Parish Consolidated Government Code of Ordinances; and

WHEREAS, Section 21-90 of the Terrebonne Parish Code currently displays budgetary and fiscal controls; and

WHEREAS, the Terrebonne Parish Division of Recreation wishes to enable and place begin with Sections 21-94 –98; and

NOW, THEREFORE, BE IT ORDAINED by the Terrebonne Parish Council on behalf of the Terrebonne Parish Consolidated Government that:

SECTION I

Section 21-90 of the Terrebonne Parish Code shall be amended, is hereby amended (using strikethrough to indicate deletions and underlining to indicate additions) and same are hereby adopted to read as follows:

Sec. 21-90. – Budgetary and fiscal controls.

- (d) [...]
 - (e) There shall be a uniform budgeting process adopted by all recreation districts including budgeting format, chart of accounts, written budget standards, and budget procedures, which shall be written by TPCG's CFO and approved by the Terrebonne Parish Council.
 - (1) Districts shall utilize the Legislative Auditor's Best Practices in reserving the fund balances.
 - a. The fund balance shall be presented to TPCG's CFO along with the annual budget.
 - (2) District budgets shall be prepared in accordance with the articles of the TPCG Charter, La. R.S. 39:1301 *et seq.*, the Local Budget Act, and Legislative Auditors Best Practices.

SECTION II

The following sections of the Code of Ordinances of Terrebonne Parish at Chapter 21, "Recreation and Parks," shall be and are hereby enacted:

Sec. 21-94. – Board Operations/Policy Manuals

- (a) TPCG shall publish a written policies and procedures manual to be utilized by the districts.
 - 1. The written policies and procedures manual shall be submitted to the Terrebonne Parish Council for approval.
 - 2. If any amendments are needed, TPCG administration shall submit proposed changes to the Terrebonne Parish Council for approval.
 - 3. Each Recreation District shall enact the components of the policies and procedures manual no later than 90 days following the acceptance of the components by the Terrebonne Parish Council and notification of such acceptance by TPCG.
 - 4. Each Recreation District shall enact the components of any approved changes to the policies and procedures manuals within 90 days of acceptance by the Terrebonne Parish Council and notification of such acceptance by TPCG.
- (b) Each Recreation District may add components to the Policy and Procedures Manual provided that such additions are equal to or more restrictive than any requirements illustrated in the manual provided by the TPCG and approved by the Terrebonne Parish Council.
- (c) Districts shall keep their uniform policies and procedures manual updated to the most current version and easily available to the public in a central location as defined by the TPCG Recreation Policies and Procedures Manual.

Sec. 21-95. – Concession Sales

- (a) Districts shall utilize three (3) methods of handling concession sales: Contract either "for profit vendors" or "non-profit vendors" as defined in the TPCG Recreation Policies and Procedures Manual, or provide concessions themselves.
 - 1) Districts that handle their own concessions:
 - a. Shall utilize the detailed written cash handling polices found in the TPCG Recreation Policies and Procedures Manual.
 - 2) Districts that subcontract their concessions to "for profit" vendors:
 - a. Shall utilize agreements published in the TPCG Recreation Policies and Procedures Manual and adopted by a majority of the Recreation District Board.
 - 3) Districts that subcontract the concessions to non-profit vendors.
 - a. Shall utilize agreements published in the TPCG Recreation Policies and Procedures Manual and adopted by a majority of the Recreation District Board.

Sec. 21-96. – Legal

- (a) Recreation Districts shall use TPCG's legal department for any legal needs. Recreation Districts may also utilize any other attorney upon the approval by the Terrebonne Parish Council.
- (b)

Sec. 21-97. – Capital Projects/ Capital Assets

- (a) Districts shall maintain a comprehensive five-year master plan.
 - 1) The five-year comprehensive mater plan shall be reviewed by each district's board of directors annually, when preparing their proposed budget.
 - a. All five-year comprehensive master plans and/or revisions thereto shall be presented to and approved by the Terrebonne Parish Council. b. If the council takes no action within thirty (30) days of receipt of the district's five-year plan, the board may adopt the five-year plan as

submitted.

- c. If the council rejects the proposed five-year plan and/or revisions within thirty
- (30) days of receipt, the council shall send written notice with specific instruction to the board for amendments to the proposed plan. The board shall then submit the amended proposed plan to the council for review.
- d. If the council takes no action within fifteen (15) days of receipt of the revised five-year plan or revisions thereto, the board may adopt the plan/revision as revised.

Sec. 21-98. – TPCG's Recreation Department

- (a) The Terrebonne Parish Recreation Department shall procure and maintain a software system that will be used as a tool to record and track all applicable components of this Section (21-98).
 - 1. The Terrebonne Parish Recreation Department shall incur 25% of the cost of purchasing and maintaining the software used to record and track all components of this Section (21-98).
 - 2. Each Terrebonne Parish Recreation District shall reimburse the Terrebonne Parish Recreation Department a prorated share of the remaining 75% of the cost of the purchase and maintenance of the software used to record and track all components of this Section (21-98).
 - 3. Each Recreation Districts' prorated share of the expenses described herein shall be determined by the attached Recreation District Millage Revenue Schedule.
 - 4. The software described in this Section shall be used by the Terrebonne Parish Recreation Department and by each Recreation District for the following functions, in an effort to jointly serve the recreation needs of the people of Terrebonne Parish:
 - a. A master list of all capital assets and resources shall be maintained. This list shall be updated perpetually as assets and resources change within each recreation district.
 - b. A perpetual scheduling instrument that will allow both the Terrebonne Parish Recreation Department and the Recreation Districts to schedule facilities for TPR events and for Recreation District events given the following protocols:
 - i. TPR sponsored programs, events, games, practices, rentals, usage and activities shall preempt any other programs, events, games, practices, rentals, usage, and activities with regard to use of Recreation District facilities.
 - ii. TPR shall book facilities to fill anticipated needs one year in advance of anticipated events.
 - 1. All bookings should be finalized within 14 days following the close of registration for anticipated events, at which time over-bookings should be removed from the centralized schedule.
 - iii. Recreation District Staff and Board may book facilities that are available according to the centralized schedule anytime within one-year in advance of anticipated event.
 - iv. Recreation Districts Staff and Board may book facilities on dates which conflict with TPR anticipated bookings or further than one-year in advance ONLY with the documented approval of the Director of TPR.
 - v. No facility programs, events, games, practices, rentals, usage of facilities, or activities will be allowed unless it is scheduled on the centralized software scheduling system in advance and in accord with the protocols set forth in this section (21-98).
 - vi. Only rental agreements provided by TPR and consistent with their Policies and Procedures Manuals may be used for facility rental.
 - vii. Any conflicts in scheduling will be resolved at the discretion of the Director of the Terrebonne Parish Recreation Department.

(b) Subject to this section, recreation districts can provide programs that TPR does not offer or that are not in direct competition with TPCG programs.

SECTION III

Any section, clause, paragraph, provision, or portion of these regulations found to be invalid is severable, and shall not affect the validity of the whole.

The Chairman recognized Mr. Norby Chabert, former State Senator, and Mr. Roosevelt Thomas, former School Board member, who were attending the evening's proceedings.

TOHSEP Director Earl Eues presented statistics on Terrebonne Parish's current COVID-19 cases, the number of tests completed, death statistics, hospitalizations, and vaccine distributions. He shared information on major and local pharmacies that are providing vaccinations as well as vaccination events at industrial sites being conducted by the Louisiana Department of Health. Mr. Eues then announced the following vaccination events:

- Boundary Road Gymnasium on June 12, 2021 from 10:00 a.m. to 2:00 p.m.
- Evergreen Cajun Center on June 12, 2021 from 11:00 a.m. to 5:00 p.m.
- Dumas Auditorium on June 19, 2021 from 10:00 a.m. to 2:00 p.m.

Upon Mr. Babin's inquiry, Mr. Eues clarified that the recent deaths reported were unvaccinated residents and then encouraged the public to get vaccinated to reduce chance of death due to the virus.

Ms. J. Domangue shared that the LA Wallet app allows Louisiana residents to update their vaccine status using their driver's license information as proof of vaccination should they need it. Mr. Eues added that the vaccination hotline is at (855) 953-0774 for more information regarding locations, scheduling, and other information.

Upon Mr. G. Michel's questioning, Mr. Eues confirmed that the CDC guidelines recommend those with compromised health conditions confer with their regular physician before getting vaccinated and that the Pfizer vaccine has been approved for vaccinating children ages 12 and older. He added that those individuals who are unable to receive the vaccine should continue following appropriate hygiene and safety measures to prevent the virus' spread.

Upon Mr. C. Harding's request, Mr. Eues clarified that a vaccine booster for COVID-19 would operate similarly to other vaccination boosters received in one's lifetime and could potentially be distributed similar to flu vaccinations. Mr. Eues encouraged the public to prepare for the current hurricane season and to visit either tpcg.org or tohsep.com to determine their evacuation zone should an evacuation order be called. He then gave an update on the work order system currently being developed for submitting and monitoring work order requests through various Parish departments.

Mr. Harding shared his optimism of the implementation of the work order system being developed to provide greater information and clarity regarding projects in Terrebonne Parish.

Mr. D. W. Guidry, Sr. led a discussion regarding the donation of parish property for the construction of an allied health center by Nicholls State University and criteria pertaining to the parish's right to rescind the donation included in the act of donation. He clarified that Nicholls State University is requesting a resolution from the Parish acknowledging that the obligations of the donation have been fulfilled to proceed with a sale of its building to the Start Corporation.

Mr. C. Harding shared his concerns relative to the health services currently being provided at the building becoming inaccessible or unaffordable for its clients should the building be sold. He expressed his opinion that the obligations had been fulfilled by NSU and suggested that additional discussion be held regarding the sale of the donated property.

Parish Attorney Julius Hebert gave an overview of the original act of donation and subsequent inclusion of a reversion clause that would provide for the property being returned to the Parish with no further action should the building on the property no longer be used for allied health purposes. He stated that Nicholls has discontinued their nursing program and has been leasing the property to the Start Corporation for some time. Mr. Hebert then shared his opinion that the building was no longer being used for its intended purpose once the nursing program ended. He continued that the Parish would have to abandon its rights to the property by ordinance, not resolution, to affect the ordinance that donated the property. Mr. Hebert then reported that a request for an Attorney General's opinion regarding the matter has been submitted by order of the Parish President and currently awaits review. He advised the Committee to consider not adopting the resolution as presented and to revisit the matter once an Attorney General opinion was rendered.

Mr. G. Michel shared his understanding of the resolution with regards to refusing to rescind the donation. He then voiced his support of the resolution and the use of the property by nonprofit organizations with related allied health services.

Mr. Hebert shared his opinions regarding a potential sale of the donated property and the conditions required to donate the property. He then reiterated his recommendation to allow an Attorney General opinion to be rendered before taking further action.

Upon Mr. D. W. Guidry's request, Mr. Norby Chabert, on behalf of Nicholls State University, gave an overview of a timeline regarding the donation of the property to Nicholls State University and related documents. He then gave a brief review of the conditions upon which the donation could be rescinded, and the property be returned to Terrebonne Parish. Mr. Chabert shared his understanding that all conditions have been met by Nicholls State University to uphold the donation at this time. He then shared the Start Corporation's goal to continue providing healthcare to their clients through its office currently located at the property.

Discussion ensued relative to the proposed sale of the property to the Start Corporation and the Parish's current responsibilities and potential issues regarding the original act of donation.

Upon Mr. S. Trosclair's questioning, Mr. Hebert shared his understanding that the issue of the property being returned to the Parish had been brought up previously, but no follow-up action was taken. He then reiterated his recommendation that the Committee delay action regarding the matter and table discussion and revisit the matter once an Attorney General opinion has been rendered.
