Mr. Travis Dupre, U19 Blackhawk Boys' Soccer Team Head Coach, thanked the Council for the recognition and shared his appreciation of the team's efforts toward competing at the national level.

At Mr. J. Navy's request, the Chairman recognized Mr. Bubba Orgeron, newly appointed Terrebonne Parish School District Superintendent, who read a commendation honoring Mr. Philip Martin upon his retirement for his years of service as Superintendent. Mr. Orgeron then highlighted several of Mr. Martin's achievements and thanked Mr. Martin for his leadership and mentorship as Superintendent.

The Chairman recognized Mr. Gregory Harding, Terrebonne Parish School Board President, who shared his appreciation for Mr. Martin as well as his legacy as part of the school system in Terrebonne Parish.

The Chairman recognized Honorable Joseph Waitz, Jr., Terrebonne Parish District Attorney, who shared some of his experiences working with Mr. Martin over the years and congratulated him on his retirement.

Mr. Orgeron recognized Mr. Mark Torbert, School District Director of Child Welfare and Attendance, and Ms. Becky Breaux, School District Chief Financial Officer, who were also attending in support of Mr. Martin.

The Chairman recognized Mr. Roger Dale Dehart, District 7 School Board Member, who shared his appreciation of Mr. Martin and thanked him for his assistance serving Terrebonne Parish.

Several Council Members shared their appreciation of Mr. Martin and thanked him for his positive impacts over many years on the School District and Terrebonne Parish as a whole.

The Chairman recognized Mr. Philip Martin, former Terrebonne Parish School District Superintendent, who thanked the Council for their service to the community and shared his appreciation of the recognition.

Parish Manager Mike Toups stated that there would not be a presentation by Parish Administration relative to capital projects, including: drainage, utility, road and quality of life projects; as well as other matters related to the operations and maintenance of Parish government; stating that there would be a presentation in two weeks.

The Chairman recognized Mr. Cohen Guidry, new CEO for the Terrebonne Economic Development Authority, who shared his optimism with serving the parish in coordination with the Council and gave a brief overview of his goals as CEO of the Authority.

At the Chairman's request, Mr. C. Harding shared that Agenda Item 1. F – "Discussion and update from the Office of Homeland Security and Emergency Preparedness relative to COVID-19 and any other pertinent public information" was pulled prior to the meeting due to

a scheduling conflict and would be revisited at a future meeting. Mr. Harding then reported that the percent positivity rate for COVID-19 in the parish is currently 27.1% positivity with less than 50% of the population vaccinated.

Mr. J. Navy noted that Dr. Eric Brooks, Region 3 Medical Director of the Office of Public Health, has been contacted to provide a monthly report to the Council regarding COVID-19 statistics and other public health concerns.

# **RESOLUTION NO. 22-221**

A RESOLUTION TO AUTHORIZE THE PARISH PRESIDENT TO ENTER INTO AN INTERGOVERNMENTAL AGREEMENT WITH THE TERREBONNE PORT COMMISSION ("TPC") AND TERREBONNE PARISH CONSOLIDATED GOVERNMENT ("TPCG") FOR THE PURPOSE OF FACILITATING IMPROVEMENTS, INCLUDING DREDGING OF THE HOUMA NAVIGATION CANAL IN CONNECTION WITH A PROJECT FOR MAINTENANCE DREDGING OF THE HOUMA NAVIGATION CANAL, AND TO PROVIDE FOR OTHER MATTERS RELATIVE THERETO.

**WHEREAS,** Article VII, Section 14 of the Louisiana Constitution further provides that "For a public purpose, the state and its political subdivisions or political corporations may engage in cooperative endeavors with each other, with the United States or its agencies, or with any public or private association, corporation or individual"; and,

WHEREAS, Section 1-07 of the Terrebonne Parish Charter provides "the parish government is authorized, as provided by state law, to enter into joint service agreements or cooperative efforts with other governmental agencies and political subdivisions"; and,

WHEREAS, Section 1-05 of the Terrebonne Parish Charter in its pertinent part provides that "The parish government shall have and exercise such other powers, rights, privileges, immunities, authority and functions not inconsistent with this charter as may be conferred on or granted to a local governmental subdivision by the constitution and general laws of the state, and more specifically, the parish government shall have and is hereby granted the right and authority to exercise any power and perform any function necessary, requisite or proper for the management of its affairs, not denied by this charter, or by general law, or inconsistent with the constitution" and furthermore, Section 1-07 of the Terrebonne Parish Charter provides "the parish government is authorized, as provided by state law, to enter into joint service agreements or cooperative efforts with other governmental agencies and political subdivisions"; and. **WHEREAS,** the Houma Navigation Canal was established during the years of the Terrebonne Parish Police Jury and prior to the creation of the TPC; and

**WHEREAS,** TPC and TPCG have been working together on a project for maintenance dredging of the Houma Navigation Canal, known and referenced as Project No. Ed 18-074, ROE for Houma Navigation Canal, Inland Channel Dredging ("Project"); and

WHEREAS, the Houma Navigation Canal is a waterway or shipway extending from Houma to the Gulf of Mexico and is an integral part of transportation by water in Terrebonne Parish and is also vital to the growth and stability of our parish and the local economy; and WHEREAS, the TPC has the authority, among other authorizations, as per LSA-R.S. 34:2203 B(5) to "... dredge and maintain shipways, bayous, waterways, channels, slips, basins and turning basins"; and

**WHEREAS**, maintenance or improvements, including dredging of the Houma Navigation Canal in accordance with the Project referenced above, should also improve navigation and also serve the interest of the public; and

**WHEREAS,** the Project referenced above serves the interest of the TPC achieving its goals and purposes; and

**WHEREAS,** upon information and belief, funding of the Project will be by the U.S. Army Corps of Engineers; and

**WHEREAS,** TPCG and TPC desire to assist each other in the Project referenced above and with the improvements to the Houma Navigation Canal; and

**WHEREAS,** TPCG and TPC desire to enter into an Intergovernmental Agreement in order to expeditiously assist in their shared mission of maintaining and/or improving the Houma Navigation Canal; and .

WHEREAS, the initial draft of the proposed Intergovernmental Agreement is attached hereto and changes thereto are expected. It is recommended by Parish Administration that an IGA between TPCG and TPC be executed in a form that allows the TPC to administer the Project and that provides for indemnity clauses by TPC in favor of TPCG all approved by the legal department; and

**NOW THEREFORE BE IT RESOLVED** by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, that the Parish President, Gordon E. Dove, be authorized to execute an Intergovernmental Agreement by and between the Terrebonne Port Commission and Terrebonne Parish Consolidated Government in substantially the same form as the Intergovernmental Agreement attached hereto or in a form that allows the Terrebonne Port Commission to administer the Project and that provides for indemnity clauses by Terrebonne Port Commission in favor of Terrebonne Parish Consolidated Government, all approved by the legal department.
