A RESOLUTION IN SUPPORT OF AN APPLICATION FOR THE CREATION OF THE HOUMA HEIGHTS CULTURAL DISTRICT SUBJECT TO THE APPROVAL OF THE LEGAL DEPARTMENT AND THE PLANNING DEPARTMENT.

**WHEREAS**, Act 298 of the 2007 Regular Session of the Louisiana Legislature authorizes Local Governing Authorities to create Cultural Districts as a mechanism for

community revitalization through the creation of hubs of cultural activity; and

**WHEREAS**, the Louisiana Department of Culture, Recreation and Tourism, Office of Cultural Development is authorized to develop standard criteria for cultural districts and to determine whether or not a proposed Cultural District meets those criteria; and

**WHEREAS**, the Louisiana Department of Culture, Recreation and Tourism, Office of Cultural Development has promulgated administrative rules which set forth the procedure for Local Governing Authorities to submit applications to designate and certify a specified geographic area as a Cultural District; and

**WHEREAS**, the geographic area within the City of Houma, Parish of Terrebonne, may meet the criteria for the creation of a Cultural District which area is generally comprised of the territory within the following boundaries: and

**WHEREAS**, within the boundaries of a state-certified Cultural District, several tax incentives may be available including (1) a sales tax exemption on the sale of certain original works of art,

(2) individual income tax credits for eligible expenses incurred during the rehabilitation of certain owner-occupied residential or owner-occupied mixed use structures, and (3) income and corporate franchise tax credits for eligible expenses incurred during the rehabilitation of certain historic structures; and

**WHEREAS**, only a Local Governing Authority is authorized to submit an application for the designation and certification of a Cultural District; and

WHEREAS, a "Local Governing Authority" is defined by LAC 25:I§1101 as "the governing authority of the parish in which the Cultural District is located unless the district is located in a municipality, in which case "Local Governing Authority" shall mean the governing authority of the municipality. If the district is located partly in a municipality, "Local Governing Authority" shall mean the governing authority of the parish and the governing authority of the municipality"; and

**WHEREAS**, the Houma Heights Cultural District is located entirely within the municipality of Houma and therefore the Terrebonne Parish Consolidated Government would be the proper entity to submit an application for the certification and designation of the above described geographic area as a Cultural District.

**NOW THEREFORE**, be it resolved that the Terrebonne Parish Consolidated Government does hereby:

- 1. Support and endorse the submission of an application to the Louisiana Department of Culture, Recreation and Tourism, Office of Cultural Development to designate the Houma Heights Cultural District as a state-certified Cultural District; and

- **NOW, THEREFORE BE IT FURTHER ORDAINED,** by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, that the 2020 Adopted Operating Budget be amended to recognize the funding for the 2020 Cities Readiness Initiative Budget. (Attachment C)

#### **SECTION IV**

- **WHEREAS**, the Parish approved the application of State of Louisiana, Office of Community Development through the Local Government Assistance Program (LGAP), reference Resolution 19-399, and
- WHEREAS, the State of Louisiana has allocated funds to be set aside for local governing bodies to decide how and where funds could be spent to help local communities, and
- **WHEREAS,** according to the Louisiana Division of Administration, Office of Community Services, Local Government Assistance Program, the Terrebonne Parish Consolidated Government has been allotted \$165,700 for the 2019-2020 fiscal year, and
- **WHEREAS**, these funds will be used to purchase four vehicles, twelve breathing apparatuses, and two industrial washer/extractor bunker gear washers.

AN ORDINANCE TO AMEND THE PARISH CODE OF TERREBONNE PARISH BY AMENDING CHAPTER 18: MOTOR VEHICLES AND TRAFFIC, ARTICLE V, SECTION 18-247, IN ORDER TO ESTABLISH "NO PARKING ANYTIME" ON THE ENTIRE LENGTH OF THE SOUTH SIDE OF ROBIN LANE INCLUDING THE RADIUS OF THE CUL-DE-SAC AND TO PROVIDE FOR THE INSTALLATION OF THE APPROPRIATE SIGNS; AND TO PROVIDE FOR OTHER MATTERS RELATIVE THERETO.

#### **SECTION I**

BE IT ORDAINED by the Terrebonne Parish Council, in regular session convened, acting pursuant to the authority invested in it by the Constitution and laws of the State of Louisiana, the Home Rule Charter for a Consolidated Government for Terrebonne Parish, and including, but not limited to, LSA R.S. 33:1368 and other statutes of the State of Louisiana, to amend the Parish Code of Terrebonne Parish, Chapter 18, Article V, Division 3, Section 18-244, in order to establish "No Parking Anytime" on the south side of Robin Lane for the length of 1,150 feet including the radius of the cul-de-sac and for the installation of said signs.

If any word, clause, phrase, section or other portion of this ordinance shall be declared null, void, invalid, illegal, or unconstitutional, the remaining words, clauses, phrases, sections and other portions of this ordinance shall remain in full force and effect, the provisions of this ordinance hereby being declared to be severable.

This ordinance shall become effective upon approval by the Parish President or as otherwise provided in Section 2-13(b) of the Home Rule Charter for a Consolidated Government for Terrebonne Parish, whichever occurs sooner.
