# **IN REGULAR SESSION**

### **DECEMBER 09, 2020**

The Chairman, Mr. S. Trosclair, called the meeting to order at 6:00 p.m. in the Terrebonne Parish Council Meeting Room. Following the Invocation, offered by Councilman S. Trosclair, Councilwoman J. Domangue led the Pledge of Allegiance.

Upon roll call, Council Members recorded as present were: J. Domangue, D. W. Guidry, Sr., D. Babin, D. J. Guidry, S. Trosclair, J. Navy, C. Harding, G. Michel, and J. Amedée. A quorum was declared present.

Mr. J. Navy moved, seconded by Mr. J. Amedée, "THAT, the Council approve the minutes of the Regular Council Session held on November 04, 2020."

The Chairman called for a vote on the motion offered by Mr. J. Navy. THERE WAS RECORDED: YEAS: J. Domangue, D. W. Guidry, Sr., D. Babin, D. J. Guidry, S. Trosclair, J. Navy, C. Harding, G. Michel, and J. Amedée. NAYS: None. ABSENT: None. The Chairman declared the motion adopted.

Mr. J. Navy moved, seconded by Mr. J. Amedée, "THAT, the Council approve the Accounts Payable Bill Lists dated 11/23/2020, 11/30/2020, and 12/07/2020."

Councilman J. Navy read a commendation commending Mrs. Margie Scoby for her research and acknowledging the discovery of Terrebonne Parish African-American Sheriffs in the history of Terrebonne Parish.

Mrs. Margie Scoby thanked the Council for acknowledging her research and provided the Council with background information on the sheriffs.

Sheriff Tim Soignet agreed that the sheriffs deserved to be recognized and was honored that he was included in this discovery.

Office of Homeland Security and Emergency Preparedness Director Earl Eues provided the Council with current confirmed cases, percent positivity rate, and other COVID-19 related data.

Dr. "Chip" Riggins, Region 3 Medical Director for the Office of Public Health, addressed the Council in regard to the current increase of COVID-19 cases across Louisiana, the lack of ICU beds in Region 3, the efficacy of current vaccine options, side effects, and a loose timeline on when the vaccines will be received and distributed to Louisiana residents. He informed the public that even though the vaccine was created within a shorter timeframe, the safety and efficiency of the vaccine was not compromised.

Upon questioning by Councilman G. Michel, Dr. Riggins informed the Council that there isn't any data showing that Mardi Gras parades can be safely conducted during this pandemic.

Councilwoman J. Domangue suggested that the Parish look at ways to increase bed capacity in the area and that Public Health Officials mass distribute the flu vaccine to counteract a possible uptick in flu cases, which could help to avoid overwhelming local area hospital beds; stating that those beds could be used for COVID-19 patients.

Dr. Riggins stated that the CDC has clarified and further emphasized the benefits of wearing masks for the wearer and the individuals around them, whether the event/activity is being held indoors or outdoors.

#### **ORDINANCE NO. 9214**

TO BIFURCATE THE VEGETATION AND MOSQUITO OPERATIONS OF THE TERREBONNE PARISH CONSOLIDATED GOVERNMENT BY MOVING THE RESPONSIBILITIES OF VEGETATION CONTROL TO THE DEPARTMENT OF SOLID, RECYCLING WASTE HAZARDOUS, AND AND THE RESPONSIBILITIES OF MOSOUITO CONTROL TO THE DIVISION OF DRAINAGE, ROADS, AND BRIDGES UNDER THE PUBLIC WORKS DEPARTMENT, TO AMEND SECTION 2-82 TO ACCOMPLISH THIS GOAL; TO AMEND SECTION 14-26 TO DEFINE THE TERM "VEGETATION"; TO AMEND SECTION 13-42 TO **REDEFINE THE TERM "ENFORCEMENT OFFICER" FOR PURPOSES** CONSISTENT WITH THE AMENDMENTS HEREIN; AND TO PROVIDE FOR RELATED MATTERS.

WHEREAS, the Terrebonne Parish Consolidated Government (TPCG) is a Home Rule Charter local government and is granted the liberally construed "right and authority to exercise any power and perform any function necessary, requisite or proper for the management of its affairs" and "to promote, protect, and preserve the general welfare, safety, health, peace and good order of the parish," not denied by the Charter, by general law, or inconsistent with the Constitution, per Louisiana Constitution Articles VI §§ 5-6 and Terrebonne Parish Charter Sections 1-01, 1-05, 1- 06, and 8-08; and

**WHEREAS,** Section 2-98 of the Terrebonne Parish Code of Ordinances provides that the Council "may, by ordinance, propose the creation, change, alteration, consolidation or abolition of parish departments, offices and agencies and/or the reallocation of the functions, powers, duties and responsibilities of such departments or agencies"; and

WHEREAS, Section 4-13 of the Terrebonne Parish Charter provides that the council "must approve [...] reorganizational efforts pursuant to Terrebonne Parish Code of Ordinances at Section 2-98; and

**WHEREAS**, Section 4-13 of the Terrebonne Parish Charter provides that the Parish President or the Council may "propose the creation, change, alteration, consolidation or abolition of parish departments, offices and agencies and/or the reallocation of the functions, powers, duties and responsibilities of such departments or agencies, including those provided for in this charter" and,

WHEREAS, the Terrebonne Parish Council desires to adopt an ordinance to reorganize the vegetation and mosquito control operations currently under the Public Works Department, and to bifurcate those responsibilities, with mosquito control operations under the Drainage, Roads and Bridges Division of Public Works Department, and vegetation control under the Solid, Hazardous, and Recycling Waste Department as further described herein; and to amend the Terrebonne Parish Code of Ordinances to provide for the same.

**NOW THEREFORE, BE IT ORDAINED** by the Terrebonne Parish Council on behalf of the Terrebonne Parish Consolidated Government that:

# SECTION I. AMENDMENT OF CHAPTER 2, ARTICLE IV, SECTION 2-82

Section 2-82(b) of the Terrebonne Parish Code of Ordinances shall be and is hereby amended as follows (using strikethrough to indicate deletions and underline to indicate additions):

Sec. 2-82. – Solid, Hazardous, and Recycling Waste Department.

[...]

(b) The director of the Solid, Hazardous, and Recycling Waste Department shall direct and be responsible for the following:

- (1) collection, transportation, and proper disposal of solid waste;
- (2) transfer stations, residential drop-off sites, and landfills;
- (3) street sweepers, grapple trucks, litter crews, and residential site labor;
- (4) the community recycling program;
- (5) promotion of education as to the proper method of disposal of solid waste;
- (6) other such responsibilities as may be directed by the president;
- (7) collection, transportation, and proper disposal, subject to all state law
- statutes and regulations; and (8) vegetation control

# SECTION II. REORGANIZATION

2.1 The Department of Solid, Hazardous, and Recycling Waste shall and does hereby assume the responsibilities of the vegetation control operations currently performed by the Department of Public Works.

2.2 The Drainage, Roads, and Bridges Division of the Department of Public Works shall retain the responsibilities of the mosquito control operations currently performed by it under the Department of Public Works.

2.3 Employees responsible for vegetation control under the Department of Public Works, equipment, and funding shall be transferred to the Solid, Hazardous, and Recycling Waste Department in accordance with the direction of administration. All employees transferred by this section shall maintain their current rates of pay and job descriptions.

2.4 In the event job positions within their new departments must be reorganized, the Department, through its Director, shall submit an organizational plan and any revised job descriptions for approval in compliance with Terrebonne Parish Code Sections 2-98 and 99.

# SECTION III. AMENDMENT OF CHAPTER 2, ARTICLE XI, SECTION 2-260

Chapter 2, Article XI of the Code of Ordinances of Terrebonne Parish, Section 2-260 shall be amended, is hereby amended (using strikethrough to indicate deletions and underlining to indicate additions) and same are hereby adopted to read as follows:

Sec. 2-260. — Parish property clean air and tobacco-free environment law.

(a) Purpose and scope. It is the intent of this section to prohibit and ban smoking of tobacco or any other substance or the use of any tobacco products on parish property set out herein.

- (b) Definitions. For the purposes of this section, the following definitions apply:
- (1) Parish property means the entirety of the legal parameters of the following properties owned, leased or otherwise controlled by the Terrebonne Parish Consolidated Government, specifically, but not exclusively, including all outdoor parking areas, inside vehicles, garages, parking lots, common areas and green spaces:

# SECTION IV. AMENDMENT OF CHAPTER 14, ARTICLE II, SECTION 14-26

Chapter 14, Article II of the Code of Ordinances of Terrebonne Parish, Section 14-26 shall be amended, is hereby amended (using strikethrough to indicate deletions and underlining to indicate additions) and same are hereby adopted to read as follows:

Sec. 14-26. - Words and terms defined.

For the purposes of this chapter, the following terms, phrases, words and derivations shall have the meaning given herein, unless it is apparent from the context that a different meaning is intended:

[...]

*Tall grass* means grass or weeds and other vegetation more than twelve (12) inches in height when measured perpendicular from the ground. This term does not include ornamental vegetation, landscaping or agricultural plants to the extent these plantings do not create a threat to the safety and welfare of citizens or do not materially interfere with another in the peaceful possession of his property.

Trash. See "Junk".

*Vegetation* means grass, high weeds, brush, climbing vines, shrubbery, and trees. This term also includes but is not limited to hydrophytic plants, macrophytic plants, algae, and/or plants that grow partly or wholly in water, whether rooted in mud or floating without anchorage.

*Vessel* means any tug, towboat, barge, watercraft, ship vessel, equipment, machinery, or any object of any kind or description, whether foreign or domestic, in a sunken or partially sunken state; the term "vessel" is also a junk vessel on property.

### SECTION V. AMENDMENT OF CHAPTER 13, ARTICLE III, SECTION 13-42

Chapter 13, Article III of the Code of Ordinances of Terrebonne Parish, Section 13-42 shall be amended, is hereby amended (using strikethrough to indicate deletions and underlining to indicate additions) and same are hereby adopted to read as follows:

# Sec. 13-42. — Definitions.

For the purposes of this division, the following terms shall have the following

meanings: [...]

*Enforcement officer* means the Superintendent of the Vegetation and Mosquito Control Division Drainage, Roads, and Bridges Division of Terrebonne Parish or other designated representatives of the division, including authorized contractors.

# SECTION VI. SEVERABILITY

Any and all other provisions of the Code not amended herein, shall remain in full force and effect. If any word, clause, phrase, section or other portion of this ordinance shall be declared null, void, invalid, illegal, or unconstitutional, the remaining words, clauses, phrases, sections and other portions of this ordinance shall remain in full force and effect, the provisions of this ordinance hereby being declared to be severable.

This ordinance shall become effective on January 1, 2021.

**WHEREAS**, Terrebonne Parish Consolidated Government (TPCG) does provide comprehensive Fireman's package policy with numerous coverages and Machinery coverage through its Risk Management Department; and

**WHEREAS**, TPCG's current comprehensive Fireman's policy is scheduled to renew on April 1, 2021; and

WHEREAS, The Terrebonne Parish Council, pursuant to Section 2-229 of the Terrebonne Parish Code of Ordinances, has selected an insurance Agent/Producer of record for Firemen's coverage for the year 2021, commencing April 1, 2021, and effective through March 31, 2022; and

**WHEREAS**, the Agent of Record has given the TPCG the option for two (2) one-year renewals for Firemen's coverage, from April 1, 2022 through March 31, 2024 subject to this Council's selection and approval by ordinance and TPCG's signing a new, but same contract for the option period;

**WHEREAS,** TPCG's current boiler and machinery coverage is scheduled to renew on March 1, 2021; and

WHEREAS, The Terrebonne Parish Council, pursuant to Section 2-229 of the Terrebonne Parish Code of Ordinances, has selected an insurance Agent/Producer of record for Boiler and Machinery coverage for the year 2021, commencing March 1, 2021, and effective through February 28, 2022,

**WHEREAS**, the Agent of Record has given the TPCG the option for two (2) one-year renewals for Boiler and Machinery coverage, from March 1, 2022 through March 31, 2024, subject to this Council's selection and approval by ordinance and TPCG's signing a new, but same contract for the option period; and

#### **SECTION I**

**NOW THEREFORE BE IT ORDAINED** by the Terrebonne Parish Council on behalf of the Terrebonne Parish Consolidated Government that <u>The Ledet Corporation d/b/a</u> <u>Ledet Insurance</u> is hereby appointed to serve as Agent/Producer of Record for the TPCG's (Houma Fire Department's) Comprehensive Fireman's Policy and the Boiler and Machinery coverage contract, submitted to Council on the 9<sup>th</sup> of December, 2020, the period of the Firemen's Policy coverage commencing April 1, 2021, and effective through March 31, 2022; and the period of the Boiler and Machinery coverage March 1, 2021, and effective through February 28, 2022.

#### **SECTION II**

**NOW THEREFORE BE IT FURTHER ORDAINED** that, for both Firemen's coverage and Boiler/Machinery coverage, the Terrebonne Parish Consolidated Government reserves the right to exercise the option to renew the appointment for up to two additional, subsequent one-year terms by signing a new contract for the new option term containing the same terms and conditions of the original contract, unless additional or other terms and conditions are specified by TPCG, subject to approval by TPCG.

# **SECTION III**

DOVE TO ISSUE PARKING PERMITS TO COAST GUARD PERSONNEL NEAR THE ALLEN ELLENDER BUILDING AS MORE FULLY DESCRIBED HEREIN; TO AMEND SECTION 18-289 TO PROVIDE FOR PARKING FEE EXEMPTION FOR UNITED STATES COAST GUARD MARINE SAFETY UNIT PERSONNEL IN CERTAIN PARKING SPACES ALONG LAFAYETTE AND GRINAGE STREETS; TO ENACT SECTION 2-453 OF THE TERREBONNE PARISH CODE TO ALLOW PARKING AT THE ROBERT J. "BOBBY" BERGERON PARKING GARAGE FOR CERTAIN ENTITIES IN FURTHERANCE OF PUBLIC SAFETY.

**WHEREAS,** The United States Coast Guard's Marine Safety Unit is located at 423 Lafayette Street, Suite 204, Houma, LA, 70360, and Marine Safety Unit provides immeasurable service to Terrebonne Parish, ensuring the health, safety, and welfare of its residents;

**WHEREAS**, Terrebonne Parish Home Rule Charter Section 2-11(a)(10), requires an Ordinance by the Terrebonne Parish Council to authorize the Terrebonne Parish Consolidated Government to abandon property owned by the parish government;

WHEREAS, Terrebonne Parish Consolidated Government wishes to provide adequate parking for the Marine Safety Unit personnel near its location; that it is not gratuitous or prohibited by Louisiana Constitution Article VII Section 14; and that the fees waived are exchanged in return for Public Safety measures

#### **SECTION I**

**NOW THEREFORE BE IT ORDAINED** by the Terrebonne Parish Council, acting pursuant to the authority vested in it by the Terrebonne Parish Home Rule Charter and the Constitution and laws of the State of Louisiana, in regular session convened, on behalf of the Terrebonne Parish Consolidated Government and in consideration of the Marine Safety Unit's service in regards to Emergency and Public Safety efforts in Terrebonne Parish, that outstanding parking fees and fines previously incurred by the United States Coast Guard personnel, in their official capacities, are hereby waived;

# **SECTION III**

Section 2-453- Terrebonne Parish Parking Garage Use During Emergencies

The Terrebonne Parish President is hereby authorized to grant temporary use of Levels 5 and 6 of the parking garage to emergency responders, public safety agencies, and disaster recovery agencies during or in the aftermath of storm events or declared States of Emergency, if, in his discretion the temporary use of the parking area would facilitate the TPCG's ability to promote the health, safety, or welfare of the citizens of the parish. The grant shall be in writing and in the form of executive order. The Grantee shall obtain and maintain insurance as described in Section 452(e)(1) of this code for the duration of the grant. The Parish President may revoke the temporary grant of use at any time by subsequent executive order. The United States Coast Guard Houma Marine Safety Unit shall notify both the TPCG Parish Manager and the TPCG Government Buildings Manager whenever they plan to use the TPCG Parking Garage Facility located across Gabasse Street from the Robert J. "Bobby" Bergeron Government Towers Building located at 8026 Main Street, Houma, LA.

#### **SECTION IV**

**NOW THEREFORE BE IT FURTHER ORDAINED** that Section 18-289 of the Terrebonne Parish Code of Ordinances is hereby amended as follows:

Sec. 18-289

The parish council may designate zones in which parking meters shall be installed. The following streets in the City of Houma are hereby designated and established as parking meter zones for the times shown:

The determination is subject to judicial review. The exempt zones are as follows:

Lafayette Street, between School Street and Verret Street;

The east side of Lafayette Street, between Wood Street and Verret Street;

The west side of Lafayette Street, between High Street and Wood Street;

Grinage Street, between Verret Street and Main Street
