At the request of Mr. J. Amedée, Chief Financial Officer Kandace Mauldin explained that the Parish had allocated 3 million dollars from the American Rescue Plan Fund and that additional funding that was being received from the state.

At Mr. J. Amedée's request, Housing and Human Services Director Kelli Varnado stated that her office executed a MOU (Memorandum of Understanding) before the end of 2024 that satisfied a required deadline to use the American Rescue Plan funding. She added that the Parish also received funding from HUD's Home Investment Partnership Program for this specific purpose to bridge a gap in financing with St. Bernard Project.

At the request of Mr. C. Harding, Ms. Varnado explained that there are 20 lots allocated to low-income housing that will be managed by Options for Affordable Housing and that St. Bernard Project will purchase 48 lots and develop 112 units for affordable housing with 10 of those units being allocated for seniors.

Discussion ensued relative to the need for housing within Terrebonne Parish and possible changes that could aid a larger number of senior citizens, if necessary, through project-based housing. (\*RESOLUTION ADOPTED AFTER DISCUSSION)

# A RESOLUTION RATIFYING A CONDITIONAL AWARD OF \$5,350,470.80 IN AFFORDABLE HOUSING GRANT FUNDS TO ST. BERNARD PROJECT, INC FOR THE DEVELOPMENT OF AFFORDABLE RENTAL HOUSING AT PARKWOOD PLACE SUBDIVISION

**WHEREAS**, the Terrebonne Parish Consolidated Government (TPCG) is committed to addressing the affordable housing needs within Terrebonne Parish; and

WHEREAS, TPCG has allocated funding in the amount of \$1,095,000.00 from the HOME Investment Partnerships Program, \$1,050,470.80 from the HOME American Rescue Plan (HOME-ARP) Program, \$3,000,000.00 from the State and Local Fiscal Recovery Funds under the American Rescue Plan Act (SLFRF), and \$205,000.00 from Housing Program

Income funds, for the specific purpose of supporting the development of affordable rental housing at the Parkwood Place Subdivision; and

**WHEREAS**, a Notice of Funding Availability (NOFA) was duly published on February 10, 2023, inviting proposals for the development of affordable rental housing at the Parkwood Place Subdivision; and

**WHEREAS**, following a comprehensive review and evaluation, a conditional award totaling \$5,350,470.80 was made to St. Bernard Project, Inc, to support a project estimated to cost in excess of \$26,000,000.00; and

WHEREAS, the award was made conditional upon St. Bernard Project, Inc securing the balance of funding necessary for project completion and adhering to all applicable requirements and regulations of the U.S. Department of Housing and Urban Development (HUD), the U.S. Department of the Treasury, and TPCG; and

WHEREAS, St. Bernard Project, Inc has successfully secured the required remaining funding and has committed to the development of ninety (90) units of affordable rental housing, consisting of duplexes and single-family units, with at least ten (10) units designated exclusively for senior residents; and

**NOW, THEREFORE, BE IT RESOLVED** by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, that the conditional award of \$5,350,470.80 in affordable housing grant funds to St. Bernard Project, Inc for the development of affordable rental housing at the Parkwood Place Subdivision is hereby ratified.

# **ORDINANCE NO. 9710**

AN ORDINANCE TO AMEND ARTICLE II, CHAPTER 11, OF THE TERREBONNE PARISH CODE, SECTION 11-34 TO PROVIDE AN INCREASE IN DISPOSAL CHARGES, FOR THE ADDITION OF A NEW CLAUSE IN ARTICLE II, CHAPTER 11, OF THE TERREBONNE PARISH CODE, SECTION 11-34 TO PROVIDE DISPOSAL CHARGES FOR RECYCLING FOR FIRMS, CORPORATIONS, OR OTHER COMMERCIAL ENTITIES, AND TO PROVIDE FOR AN ANNUAL INCREASE IN COMMERCIAL DISPOSAL CHARGES PURSUANT TO THE CONSUMER PRICE INDEX

# **SECTION I**

WHEREAS, Section 1-06 of the Home Rule Charter for Terrebonne Parish Consolidated Government (TPCG) provides that the Parish Government shall have the right, power and authority to pass all ordinances requisite or necessary to promote, protect and preserve the general welfare, safety, health, peace and good order of the parish, including but not by way of limitation, the right, power and authority to pass ordinances on all subject matters necessary requisite or proper for the management of parish affairs, and all other subject matters without exception, subject only to the limitation that the same shall not be inconsistent with the Constitution or expressly denied by general law applicable to the parish; and

WHEREAS, Section 2-11 of the Terrebonne Parish Home Rule Charter requires an ordinance to adopt or amend an administrative code; and

**WHEREAS**, the Solid Waste Department of the Terrebonne Parish Consolidated Government handles the disposal of solid waste in Terrebonne Parish;

WHEREAS, the current disposal charges outlined in Article II, Chapter 11, Section 11-34 of the Terrebonne Parish Code are in need of an increase for firms, corporations, and other commercial entities to account for costs of operation and maintenance;

WHEREAS, the disposal charges as outlined in Article II, Chapter 11, Section 11-34 of the Terrebonne Parish Code do not currently include disposal costs for recycling for firms, corporations, or other commercial entities; and

WHEREAS, TPCG wishes to amend Article II, Chapter 11, Section 11-34 of the Terrebonne Parish Code to provide an increase in disposal charges, for the addition of a new clause to provide for disposal charges for recycling for firms, corporations, or other commercial entities, and to provide for an annual increase in commercial disposal charges pursuant to the consumer price index.

# SECTION II

**NOW, THEREFORE, BE IT ORDAINED** by the Terrebonne Parish Council on behalf of the Terrebonne Parish Consolidated Government that the following sections of the Code of Ordinances of Terrebonne Parish at Chapter 11, Article II, Section 11-34 shall be and are hereby adopted, with underline to show additions:

\*\*\*

#### Sec. 11-34. – Disposal charges.

(a) Except as provided in any contractual agreement to which the parish is a party and excepting the application of a schedule of volumetric charges as hereinafter provided, any person, firm, or corporation, or other entity, individually, or collectively, disposing of solid

waste which is generated upon the premises of their business or personal household within the parish, at any parish solid waste facility, shall pay a disposal fee of forty-two <u>fifty-three</u> dollars (42.00) (53.00) per ton. Any person, firm, or corporation, <u>or other entity</u>, individually or collectively, disposing of solid waste which is generated outside the parish, at any parish solid waste facility, under a permit issued pursuant to section 11-32(d), shall pay a disposal fee of not less than forty-five <u>fifty-six</u> dollars (45.00) (56.00) per ton or the actual cost to the parish of waste handling, transportation and disposal, whichever is greater.

(b) Commercial or other entity recycling waste disposal charges. Except as provided in any contractual agreement to which the parish is a party and excepting the application of a schedule of volumetric charges as hereinafter provided, any firm, corporation, or other commercial or other entity, individually, or collectively, disposing of recycling waste which is generated upon the premises of their commercial or other entity's property within the parish, at any parish solid waste facility, shall pay a disposal fee of three hundred twenty-five dollars (\$350.00) per ton. Any firm, corporation, or other commercial entity, individually or collectively, disposing of recycling waste which is generated upon the premises of their business outside the parish, at any parish solid waste facility, under a permit issued pursuant to section 11-32(d), shall pay a disposal fee of not less than three hundred fifty dollars (\$375.00) per ton or the actual cost to the parish of waste handling, transportation and disposal, whichever is greater

(c) Consumer Price Index. All disposal charges shall be adjusted thereafter every January 1 based on the percentage change in the Consumer Price Index from the initial charges listed in sections (b)(1) and (b)(2) above, to be capped at 5%. The annual adjustment will equal a U.S. City Average 12-month percentage change in the All Urban Consumers-All Items Index (CPI-U) as compiled by the Bureau of Labor Statistics. Any adjustment shall be published in the official journal of the Parish of Terrebonne and on the Terrebonne Parish Consolidated Government Website prior to implementation.

(d) Any person desiring to dispose of tires at the parish transfer station at Ashland, Louisiana, shall pay a disposal fee as set forth in this subsection. This provision shall not be applicable to persons disposing of four (4) or fewer small tires per trip, if such tires are removed from that person's personal nonbusiness vehicle.

- (1) Small size tires up to but not to include tire size 700, each \$3.00
- (2) Tire size 700 and up to but not to include tire size 900, each \$5.00
- (3) Tire size 900 and up to but not to include tire size 1200, each \$7.00
- (4) No tires size 1200 and over shall be accepted for disposal.

(e) The utilities <u>solid waste</u> director or his designee shall develop rules and regulations governing the collection and payment of the disposal charges set forth herein. Additionally, the schedule of charges to be applied to residential and small commercial drop-off waste on a volumetric basis shall be presented to the parish council and effective upon adoption by resolution.
