RESOLUTION NO. 25-296

A resolution approving the holding of an election in Recreation District No. 6 of the Parish of Terrebonne, State of Louisiana, on Saturday, November 15, 2025, to authorize the issuance of general obligation bonds therein.

WHEREAS, the Board of Commissioners of Recreation District No. 6 of the Parish of Terrebonne, State of Louisiana (the "Governing Authority"), acting as the governing authority of Recreation District No. 6 of the Parish of Terrebonne, State of Louisiana (the "District"), adopted a resolution on July 1, 2025, calling a special election in the District on Saturday, November 15, 2025, to authorize the issuance of general obligation bonds therein; and

WHEREAS, the Governing Authority of the District has requested that this Parish Council, acting as the governing authority of the Parish of Terrebonne, State of Louisiana, give its consent and

authority for the District to hold the aforesaid election, and in the event that the election carries for further authority to issue, sell and deliver the bonds provided for therein; and

WHEREAS, as required by Article VI, Section 15 of the Constitution of the State of Louisiana of 1974, it is now the desire of this Parish Council to approve the holding of said election and in the event that the election carries, to issue, sell and deliver the bonds provided for therein;

NOW, THEREFORE, BE IT RESOLVED by the Parish Council of the Parish of Terrebonne, State of Louisiana, acting as the governing authority of said Parish, that:

SECTION 1. In compliance with the provisions of Article VI, Section 15 of the Constitution of the State of Louisiana of 1974, and in accordance with the request of the Board of Commissioners of Recreation District No. 6 of the Parish of Terrebonne, State of Louisiana, this Parish Council hereby approves the holding of an election in the District, on Saturday, November 15, 2025, at which election there will be submitted the following proposition, to-wit:

PROPOSITION (BOND)

Shall Recreation District No. 6 of the Parish of Terrebonne, State of Louisiana (the "District"), incur debt and issue bonds to the amount of not exceeding \$2,440,000, to run not exceeding 20 years from the date thereof, with interest at a rate not exceeding 7% per annum, for the purpose of purchasing, acquiring, constructing, and improving parks, playgrounds, and other recreational facilities, together with the necessary furnishings and equipment therefor, title to which shall be in the public, which bonds will be general obligations of the District and will be payable from ad valorem taxes to be levied and collected in the manner provided by Article VI, Section 33 of the Constitution of the State of Louisiana of 1974, and statutory authority supplemental thereto, with no estimated increase in the millage rate to be levied in the first year of issue above the 5.30 mills currently being levied to pay General Obligation Bonds of the District?

SECTION 2. In the event the election carries, this Parish Council does hereby further consent to and authorize the District to issue, sell and deliver the bonds provided for therein.

SECTION 3. Neither the Parish nor this Parish Council shall be liable in any manner for the payment of the bonds.

RESOLUTION NO. 25-304

A RESOLUTION TO APPROVE GULF ISLAND, LLC FOR PARTICIPATION IN THE INDUSTRIAL TAX EXEMPTION PROGRAM AT TERREBONNE PARISH, LOUISIANA

WHEREAS, Article 7, Section 21(F) of the Louisiana Constitution provides for the Board of Commerce and Industry ("BCI"), with the approval of the Governor, to approve contracts for the exemption of ad valorem taxes of a new manufacturing establishment or an addition to an existing manufacturing establishment, on such terms and conditions as the board, with the approval of the Governor, deems in the best interest of the state; and

WHEREAS, Gulf Island, LLC has applied for an Industrial Tax Exemption ("ITE"), #20230387-ITE, which has been approved by the BCI; and

WHEREAS, Executive Order JBE 16-26 and 16-73, as amended, provides that ITE contracts should be premised upon job and payroll creation at new or expanded manufacturing plants or establishments, or upon showing that investment in modernization of the facility represents a compelling basis for retention of jobs, based upon economic benefit in accordance with guidance received from the Secretary of Economic Development and concurred by the Terrebonne Parish Council, Terrebonne Parish School Board and Terrebonne Parish Sheriff; and

WHEREAS, Executive Order JBE 16-26 and 16-73, as amended, further requires that this Parish Council, together with the other required local government entities signify consent to the terms of the exemption; and

ORDINANCE NO. 9723

AN ORDINANCE TO AMEND SECTION 22-168 OF THE TERREBONNE PARISH CODE AND TO RENUMBER THE SAID SECTION TO CHAPTER 6, SECTION 6-23 OF THE TERREBONNE PARISH CODE OF ORDINANCES, AND TO PROVIDE FOR RELATED MATTERS

WHEREAS, Section 1-06 of the Home Rule Charter for Terrebonne Parish Consolidated Government (TPCG) provides that the Parish Government shall have the right, power and authority to pass all ordinances requisite or necessary to promote, protect and preserve the general welfare, safety, health, peace and good order of the parish, including but not by way of limitation, the right, power and authority to pass ordinances on all subject matters necessary requisite or proper for the management of parish affairs, and all other subject matters without exception, subject only to the limitation that the same shall not be inconsistent with the Constitution or expressly denied by general law applicable to the parish; and

WHEREAS, Section 2-11 of the Terrebonne Parish Home Rule Charter requires an ordinance to adopt or amend an administrative code: and

WHEREAS, Section 22-168 of the Terrebonne Parish Code of Ordinances provides for the consideration of drainage in Terrebonne Parish when constructing commercial and industrial buildings; and

WHEREAS, Section 22-168 is not clear on which TPCG department is responsible for reviewing drainage plans for this type of construction and the location of the provisions should be moved to the building code section of the Code to facilitate compliance; and

WHEREAS, TPCG desires to renumber Section 22-168 to Section 6-23 and to amend subsection (5) of the ordinance to clarify the proper TPCG department which will review drainage plans; and

WHEREAS, as a matter of housekeeping, TPCG desires to renumber Section 22-169 to Section 22-168; and.

NOW, THEREFORE, BE IT ORDAINED by the Terrebonne Parish Council on behalf of the Terrebonne Parish Consolidated Government that:

SECTION I

Section 22-168 is hereby renumbered to Section 6-23 of Chapter 6 of the Code of Ordinances of Terrebonne Parish, and shall be and is hereby amended as follows (underlining to indicated additions):

Sec. 22-168. Sec. 6-23. Commercial or industrial development impeding rainfall absorption; approval and conformity required.

For the approval of a building permit application, all proposed commercial or industrial developments shall have submitted adequate plats, plans, calculations and approvals necessary to demonstrate that they meet the following requirements.

- (1) All commercial or industrial development:
 - a. Which will result in making impervious to rainfall (concrete, blacktop and/or structures) more than seventy (70) percent of a lot or more than ten thousand (10,000) square feet of a lot including structures; and
 - b. Which is not in a development that has received engineering approval for commercial or industrial development from the planning commission after the passage of Ordinance No. 5293 (8/25/94); or
 - c. In all cases which will result in making impervious to rainfall more than seventy (70) percent of a lot, the plans shall be submitted to the TPCG Department of Public Works for approval. The development of the property shall conform to the requirements of the TPCG's Storm Drainage Design Manual, as amended.
- (2) The construction of any improvements to be dedicated to the parish government shall be constructed in accordance with the latest State of Louisiana Standard Specifications for Roads and Bridges by the LaDOTD and shall comply with the latest LaDOTD Standard Plans. Exceptions to the use of these standard plans and specifications will only be allowed with written approval by the director of public works or his designee.
- (3) Any rights-of-way or servitudes dedicated for acceptance by the parish shall meet the requirements of section 8.1.1 of Appendix B of the parish Code.
- (4) To provide for the health, safety and welfare of the citizens and as required by site plan and/or engineering necessity, the director of planning and zoning is authorized to condition the issuance of a building permit by placing specific direction on the permit regarding the timing of the initiation and completion of any drainage mitigation work.
- (5) Prior to the issuance of the certificate of occupancy, the project engineer shall certify, to TPCG's engineering department, that any drainage improvements have been built in accordance with approved plans and specifications.

SECTION II

The current Section 22-169 of Chapter 22 of the Code of Ordinances of Terrebonne Parish shall be and is hereby renumbered to 22-168. Section 22-169 shall be reserved.

SECTION III

NOW, LET IT FURTHER BE ORDAINED any section, clause, paragraph, provision, or portion of these regulations found to be invalid is severable and shall not affect the validity of the whole.

SECTION IV

NOW, LET IT FURTHER BE ORDAINED this ordinance shall become effective upon approval by the Parish President or as otherwise provided in Section 2-13(b) of the Home Rule Charter for a Consolidated Government for Terrebonne Parish, whichever occurs sooner. This ordinance, having been introduced and laid on the table for at least two weeks, was voted upon as follows:

ORDINANCE NO. 9724

AN ORDINANCE TO AMEND THE PARISH CODE OF TERREBONNE PARISH BY ADDING TO CHAPTER 18: MOTOR VEHICLES AND TRAFFIC, ARTICLE IV: OPERATION OF VEHICLES, DIVISION 2. - PARISH, SECTION 18-91 (B) (1), TO ESTABLISH A "15 MPH SPEED LIMIT" ZONE ALONG THE ENTIRE LENGTH OF CEDAR GROVE ROAD; TO PROVIDE FOR THE INSTALLATION OF SAID SIGNS; AND TO PROVIDE FOR OTHER MATTERS RELATIVE THERETO.

SECTION I

BE IT ORDAINED, by the Terrebonne Parish Council, in Regular Session convened, acting pursuant to the authority invested in it by the Constitution and laws of the State of Louisiana, the Home Rule Charter for a Consolidated Government for Terrebonne Parish, and including, but not limited to, LSA R.S. 33:1368 and other statutes of the State of Louisiana, to

amend the Parish Code of Terrebonne Parish, Chapter 18: Article IV, and appropriate Section to create a "15 mph Speed Limit" zone along the entire length of Cedar Grove Road.

CHAPTER 18: MOTOR VEHICLES AND TRAFFIC ARTICLE IV: OPERATION OF VEHICLES DIVISON 2. – PARISH SECTION 18-91: Speed limits. (b)(1): "Fifteen miles per hour."

The entire length of Cedar Grove Road shall be declared as a "15 mph Speed Limit" zone, and appropriate "15 mph Speed Limit" signs shall be erected and maintained along the said section of roadway. Any vehicle traveling on Cedar Grove Road shall adhere to the provisions of this ordinance.

SECTION II

If any word, clause, phrase, section or other portion of this ordinance shall be declared null, void, invalid, illegal, or unconstitutional, the remaining words, clauses, phrases, sections and other portions of this ordinance shall remain in full force and effect, the provisions of this ordinance hereby being declared to be severable.

SECTION III

This ordinance shall become effective upon approval by the Parish President or as otherwise provided in Section 2-13(b) of the Home Rule Charter for a Consolidated Government for Terrebonne Parish, whichever occurs sooner.
