

PROCEEDINGS
OF THE
NORTH TERREBONNE RECREATION DISTRICT BOARD
IN REGULAR SESSION
JULY 12, 2021

The Chairman, Gerald Michel, called the North Terrebonne Recreation District Board meeting to order at 6:34 p.m. in the Terrebonne Parish Council Meeting Room then led an Invocation and the Pledge of Allegiance. Upon roll call, Board Members recorded as present were: C. Harding, G. Michel, J. Amedée, J. Domangue, D. W. Guidry, Sr., D. Babin, D. J. Guidry, and J. Navy. Board Member S. Trosclair was recorded as absent. A quorum was declared present.

The Chairman called for comments from the public of which there were none.

Mr. J. Amedée gave a brief update regarding the current draft language for the November 2021 recreation tax proposition. He shared that changes were being made to fully ensure that potential voters understand that the tax proposition will not only levy a tax but also provide funding for a new recreation district created by merging Recreation District Nos. 1, 2, 3, 8, and 9.

The Chairman shared that the aforementioned tax proposition, if passed, would not be a duplicate tax and that the current taxes would not be imposed alongside the proposed tax.

Chief Financial Officer Kandace Mauldin reiterated that, should the tax proposition be passed and the new tax be levied for the new recreation district, the current taxes would not be imposed on the previous individual districts.

The Chairman announced that the North Terrebonne Recreation District may consider a tax proposition at its meeting (immediately following the Terrebonne Parish Council Committee meetings) on Monday, August 9, 2021 in the Robert J. Bergeron Government Tower Building located at 8026 Main Street, 2nd Floor Council Meeting Room, Houma, LA.

Ms. Mauldin clarified that consideration of the tax proposition was initially announced for another date but had to be rescheduled due to advertising issues. She then stated that, although the meeting has been rescheduled, the new date will still allow the tax proposition to be included on the November 2021 ballot.

Mr. J. Amedée moved, seconded by Mr. D. W. Guidry, Sr., “THAT, there being no further business to come before the Board, the meeting be adjourned.”

The Chairman called for the vote on the motion offered by Mr. J. Amedée.
