

**PROCEEDINGS**  
**OF THE**  
**TERREBONNE PARISH COUNCIL**  
**IN SPECIAL SESSION**

**MAY 13, 2026**

The Chairman, Mr. B. Pledger, called the Special Meeting to order at 6:00 p.m. in the Terrebonne Parish Council Meeting Room. Mr. C. Hamner led the Invocation and the Pledge of Allegiance. Upon roll call, Council Members recorded as present were: C. Voisin, Jr., J. Amedée, C. K. Champagne, C. Hamner, K. Chauvin, B. Pledger, and C. Harding. Mr. D. Babin and Mr. S. Trosclair were recorded as absent. A quorum was declared present.

The Chairman read letters from Mr. S. Trosclair and Mr. D. Babin noting their absences from the proceedings.

It was at this time the Council was recorded as entering into public hearings.

The Chairman recognized the public for comments on the following:

- A. An ordinance to adopt millage rates for tax year 2026 (with no roll-forward provisions).

The Chairman recognized Ms. Connie Bourg, a Houma resident, who voiced her concerns regarding a lack of public attendance to discuss millage rates then encouraged the public to share their opinions regarding public issues.

The Chairman noted that the millages being considered would not increase taxes from their current amounts as the millages were not subject to roll-forward provisions.

There were no further comments from the public regarding the proposed ordinance.
