MINUTES

HOUMA-TERREBONNE REGIONAL PLANNING COMMISSION (HTRPC) MEETING OF APRIL 23, 2009

- A. The Chairman, Daniel Babin, called to order the regular meeting of April 23, 2009 of the Houma-Terrebonne Regional Planning Commission (HTRPC) at 7:52 p.m. in the Terrebonne Parish Council Meeting Room with the Invocation led by Dr. Budd Cloutier and the Pledge of Allegiance led by Ms. Marsha Williams.
- B. Upon Roll Call, present were: Daniel Babin, Chairman; L. Arnold "Budd" Cloutier, Vice-Chairman; Richard Elfert; James Erny; Keith Kurtz; John Navy; Alex Ostheimer; and Marsha Williams, Secretary/Treasurer. Absent at the time of Roll Call were: Beryl Amedée. Also present were Pat Gordon, Director, and Jennifer Robinson, Senior Planner, Department of Planning and Zoning and Laddie Freeman, Legal Advisor.

C. ACCEPTANCE OF MINUTES:

D. Ms. Williams moved, seconded by Dr. Cloutier: "THAT the HTRPC emit payment for the April 23, 2009 invoices and approve the Treasurer's Report of March 2009."

 - b) The Chairman recognized Ricky Comardelle, 460 North Service Road, Developer, who discussed their plans for the development with no intentions of flooding anyone.
 - c) The Chairman recognized Councilman Kevin Voisin, District 6, who expressed the need to see elevations of the development before proceeding. He requested the matter be brought back to the Parish Council, the elected officials.
 - d) Dr. Cloutier moved, seconded by Mr. Erny and Ms. Williams: "THAT the public hearing be closed."

 - e) Mr. Gordon discussed the Staff Report and stated Pollution Control was not solicited for comments and would recommend no action until a letter from them was received to resolve the sewer capacity issue in the area.
 - f) Discussion was held with regard to making a decision based on considering the laws, tabling the matter, allowing the matter to proceed to the engineering phase to get a better idea of the impact on the neighbors, denying the development due to public safety, etc.
 - g) Mr. Elfert moved, seconded by Ms. Williams: "THAT the HTRPC deny the conceptual and preliminary application for Process C, Major Subdivision for Hollygrove based on an undefined risk hazard and the fact that it is unknown on how to engineer it."
 - h) Discussion ensued with regard to levees and flooding
 - i) Mr. Waitz stated elevations would be forthcoming shortly and discussed the area with more existing issues than what the slip would cause.

1. The Chairman called to order the Public Hearing for an application by Belmere, LP requesting approval for Process D, Minor Subdivision for the Survey and Division of Property belonging to Matherne Realty Partnership.

- a) Ms. Michan Holbrook, Coyle Engineering, discussed the location and division of property.
- b) No one was present from the public to speak.
- c) Ms. Williams moved, seconded by Mr. Ostheimer and Mr. Navy: "THAT the Public Hearing be closed."

- f) The Chairman recognized Carroll Parr, Matherne Realty Partnership, who stated the road would be paved up to Lot C-10-3 for Belmere but obligated more with Terrebonne Parish Consolidated Government.
- g) Mr. Ostheimer moved, seconded by Ms. Williams: "THAT the HTRPC grant approval to the application for Process D, Minor Subdivision for the Survey and Division of Property belonging to Matherne Realty Partnership conditioned the ditch diverting the water be dug before any building permits are issued; Enterprise Drive Extension along with the sewer line and any other infrastructure improvements be bonded, and that Enterprise Drive be built to the westernmost property line of C-10-3 and be dedicated and accepted by the Parish before any occupancy permits are issued to the apartment complex and the sewer/water lines are constructed."
- h) Discussion was held with regard to the dollar amount of the bond.

2. The Chairman called to order the Public Hearing for an application by Four Sisters Properties, L.L.C. requesting approval for Process D, Minor Subdivision for the Survey of Lots 6-A, 6-B, 6-C & 6-D, A Redivision of Lot 6, former property of Burlington Resources.

The Chairman relinquished the chair to the Vice-Chairman at this time.

- a) Mr. Ken Rembert, Keneth L. Rembert Land Surveyors, discussed the location and division of property. He stated the property would be used for docking and mooring purposes only.
- b) No one was present from the public to speak.

- e) Mr. Kurtz moved, seconded by Ms. Williams: "THAT the HTRPC grant approval to the application for Process D, Minor Subdivision for Survey of Lots 6-A, 6-B, 6-C & 6-D, A Redivision of Lot 6, former property of Burlington Resources as per Mr. Gordon's recommendations; conditioned each lot is labeled "Boathouse Only, No Camps" and submittal of an approval letter from Board of Health."

The Chairman called for a vote on the motion offered by Mr. Kurtz. THERE WAS RECORDED: YEAS: Mr. Babin, Mr. Elfert, Mr. Erny, Mr. Kurtz, Mr. Navy, Mr. Ostheimer, and Ms. Williams; NAYS: None; ABSTAINING: Dr. Cloutier; ABSENT: Ms. Amedée. THE CHAIRMAN DECLARED THE MOTION ADOPTED.

- 4. The Chairman called to order the Public Hearing for an application by C & J Enterprises, L.L.C., et al requesting approval for Process D, Minor Subdivision for the Division of Property, C & J Enterprises, L.L.C., et al.
 - a) Mr. Ben Elliott, T. Baker Smith, Inc., discussed the location and division of property.
 - b) No one was present from the public to speak.
 - c) Dr. Cloutier moved, seconded by Ms. Williams: "THAT the Public Hearing be closed."

- e) Discussion was held with regard to the application, again, stating a variance from engineering but is no longer required since changes in the subdivision regulations.
- f) Mr. Ostheimer moved, seconded by Mr. Navy: "THAT the HTRPC grant approval to the application for Process D, Minor Subdivision for the Division of Property, Jonathon Carriles and Eva Raye Smith as per Mr. Gordon's recommendations; conditioned provided Tract 3B-2a be large enough to support a 50' x 50' development box free and clear of all servitudes and rights-of-way, submittal of drainage calculations to the Terrebonne Parish Engineering Division for review and/or approval, installation of a dry hydrant as approved by the Bayou Dularge Fire Chief, and that Tract 3B-2b be utilized for mooring purposes only; it was also noted that no variance from engineering was granted."

- 6. The Chairman called to order the Public Hearing for an application by South Hollywood Properties #1, L.L.C. requesting conceptual and preliminary approval for Process C, Major Subdivision for Concord Business Park.
 - a) Mr. Brandon Arceneaux, David A. Waitz Engineering and Surveying, Inc., discussed the location and division of property.
 - b) The Chairman recognized Councilman Kevin Voisin, District 6, who stated outside of the slip, the development was good.
 - c) The Chairman recognized the following adjacent property owners who expressed their opposition with regard to flooding, storm surges, and this development being an integral part of Hollygrove Subdivision that was previously denied:

- d) Dr. Cloutier moved, seconded by Ms. Williams: "THAT the Public Hearing be closed."
 - The Chairman called for a vote on the motion offered by Dr. Cloutier. THERE WAS RECORDED: YEAS: Dr. Cloutier, Mr. Elfert, Mr. Erny, Mr. Kurtz, Mr. Navy, and Ms. Williams; NAYS: None; ABSTAINING: Mr. Babin; ABSENT: Ms. Amedée and Mr. Ostheimer. THE CHAIRMAN DECLARED THE PUBLIC HEARING CLOSED.
- e) Mr. Gordon stated that since the first segment of the master plan was denied, Hollygrove, he didn't see how they could go forward with the second segment, Concord Business Park. He stated that the slip included in this plan adjoins a development that has already been denied.
- f) Mr. Elfert moved, seconded by Ms. Williams and Mr. Navy: "THAT the HTRPC deny the application for Process C, Major Subdivision for Concord Business Park as per Mr. Gordon's reasoning; due to the first segment of the master plan (Hollygrove) being denied and a slip being included in this development that adjoins that segment."

- 7. WITHDRAWN, Cypress Gardens Subdivision (Phase A) [See *ATTACHMENT B*]
- 8. The Chairman called to order the Public Hearing for an application by Kevin & Jenny Do requesting approval for Process B, Mobile Home Park Approval for Four Seasons Mobile Home Park.
 - a) Mr. Galen Bollinger, Charles L. McDonald Land Surveying, Inc., discussed the location and division of property.
 - b) The Chairman recognized Harold Monnier, 164 Oscar Court, who expressed opposition of the mobile home park.
 - c) The Chairman recognized Adeline Pellegrin, 3115 Betty Ann, who expressed opposition of the mobile home park due to garbage, flooding, sewerage, and decrease in property values.
 - d) The Chairman recognized Nancy Williams, 318 Marie Louise, who expressed opposition of the mobile home park.
 - e) The Chairman recognized a Deputy Fire Chief with Bayou Cane Fire District, who stated the roadway was not wide enough for a fire truck to get through in order to provide protection.
 - f) Dr. Cloutier moved, seconded by Ms. Williams: "THAT the Public Hearing be closed."
