PUBLIC NOTICE

REQUEST FOR STATEMENT OF QUALIFICATIONS LAKE CHIEN LIVING SHORELINE PROFESSIONAL ENGINEERING SERVICES

The Parish is accepting Statements of Qualifications for engineering services to complete the design of a project to harden the shoreline of Lake Chien using Gabion mats or the equivalent to significantly reduce coastal erosion from storm surge protecting the pipeline infrastructure landward and the Morganza to the Gulf levee system (MTTG) beyond. The project site is located on the shoreline of Lake Chien just west of Point au Chenes, Louisiana and north of Lake Felicity and the Gulf.

Terrebonne Parish Consolidated Government has been awarded a \$5,100,000 grant from the National Fisheries and Wildlife Foundation for the purpose of constructing the Lake Chien Living Shoreline Project. The Parish requires the services of an engineering design firm to (1) complete the engineering design/permitting (in USACE review) and (2) administer and implement the construction engineering/inspection of the project including resident services.

Prime respondents shall be an engineering design firm appropriately registered with the Louisiana Professional Engineering and Land Surveying Board. The successful respondent must demonstrate that the firm or team assembled to respond to this solicitation has experience in the design and efficient implementation of shoreline projects with low environmental impacts in a dynamic coastal environment. The project has 95% plans, and the scope of work will include the remainder of the basic services and additional services as needed which may include a survey of existing conditions. The successful respondent will coordinate with the Parish or Parish Agents to document the progress during construction for educational purposes.

Qualified firms should have properly certified personnel available to complete the initial engineering and bid package within 90 days of contract award.
